appointing and replacing members of the Governing Board of the European Centre for the Development of Vocational Training

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof ¹,

Having regard to the nomination submitted by the Cypriot government,

Having regard to the nomination submitted by the Latvian government,

Whereas:

- (1) By its Decision of 16 July 2012 ², the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2012 to 17 September 2015.
- (2) A member's seat is available for Cyprus on the Governing Board of the Centre in the category of Government representatives as a result of the resignation of Mr George PAPAGEORGIOU.
- (3) A member's seat is available for Latvia on the Governing Board of the Centre in the category of Government representatives as a result of the resignation of Mr Janis GAIGALS.
- (3) The members of the Governing Board of the aforementioned Centre should be appointed for the remainder of the current term of office, which expires on 17 September 2015.
