	- Exchange of views

- 1. The <u>Commission</u> adopted the proposal for a Regulation of the European Parliament and of the Council amending Regulation 1013/2006 on shipments of waste¹, and its related impact assessment², on 11 July 2013.
- 2. The proposal and the impact assessment were presented to the Working Party on the Environment (WPE) on 6 September 2013 and delegations held a preliminary discussion on both documents. On 19 September the WPE further considered the impact assessment followed by a detailed first reading of the Commission proposal on an article-by-article basis. Further discussions in the WPE are envisaged.

I. Background

The Waste Shipment Regulation³ (WSR) lays down requirements for shipments of waste within the EU and between the EU and third countries. Article 50 of the WSR lays down general provisions on enforcement stipulating that Member States shall provide for inspections for establishments and undertakings in accordance with the Waste Framework Directive⁴. As a result of this general formulation, without specific provisions on how inspections should be carried out, differences exist between Member States with respect to inspection requirements as well as to requirements for national authorities to be able to prove that a waste shipment is illegal. This situation encourages exporters of illegal waste to send their waste through the points with least controls ('port hopping').

It is recalled that the Council, in its Conclusions of 3 June 2010⁵, invited the Commission to, inter alia, consider strengthening the EU requirements on inspections and spot checks carried out under the WSR.

Against this background, the Commission proposal contains measures to better address the problem of illegal waste shipments, having regard to their economic, social and environmental impacts, and aims to ensure a more uniform implementation of the WSR throughout the EU, in particular through introducing:

- requirements for inspection planning for waste shipments, and
- the possibility for the national competent authority to require evidence from suspected illegal waste exporters (reversing the burden of proof) in order to check the legality of waste shipments.
