- 1. The <u>General Secretariat of the Council</u> has been informed of the resignation of Ms Käthlin SANDER as member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Estonia).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006¹ provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

Having regard to Regulation (EC) No 1922/2006 of 20 December 2006 establishing the European Institute for Gender Equality², and in particular Article 10 thereof,

Whereas:

- (1) By its Decision of 29 May 2013³ the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2016.
- (2) A member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Käthlin SANDER.
- (3) The Government of Estonia has submitted a nomination for the vacant seat,
