- 1. The <u>General Secretariat of the Council</u> has been informed of the resignation of Ms Patrizia DE ROSE as member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Italy).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006¹ provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

- 3. The eighteen members and alternate members appointed by the Council represent eighteen Member States in the order of the rotating Presidencies, one member and one alternate member being nominated by each Member State.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EC) No 1922/2006 of 20 December 2006 establishing the European Institute for Gender Equality², and in particular Article 10 thereof,

Whereas:

- (1) By its Decision of 29 May 2013³ the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2016.
- (2) A member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Patrizia DE ROSE.
- (3) The Government of Italy has submitted a nomination for the vacant seat,
