The Council had an exchange of views on the CFP reform based on the Presidency note. Ministers supported the ambitious time schedule for advancing the reform during the Irish Presidency and concurred with the Presidency's outline of main political issues during the negotiations. A number of delegations highlighted additional items of political importance, pertaining to the Regulation on the Common Fisheries Policy as well as to the European Maritime and Fisheries Fund and the Common Markets Organisation.
