The mandate includes a margin of flexibility granted to the Presidency to adjust the Council position as necessary on the number of members which would be required to block the committee written procedure.

- International Organisation of Vine and Wine (OIV)
 - Commission statement

The <u>SCA</u> took note of the presentation made by the Commission of the following statement:

"Lors de l'Assemblée Générale de l'OIV le 7 juin 2013, plusieurs Etats Membres de l'Union ont voté en faveur de l'ensemble des résolutions de l'OIV à l'Assemblée Générale. Or, en l'absence de position de l'Union adoptée conformément à l'article 218(9) du Traité sur le Fonctionnement de l'Union Européenne, les Etats Membres assistant à l'Assemblée Générale de l'OIV devaient faire en sorte que les résolutions, affectant l'acquis sur lesquelles une position de l'Union faisait défaut, ne soient pas adoptées.

Bien que la Commission n'envisage pas à ce stade d'ouvrir ou de poursuivre des procédures d'infraction, la Commission considère que, les Etats membres concernés ont manqué à leurs obligations de respecter la compétence exclusive de l'Union ainsi qu'à leur obligation de coopération loyale.

La Commission reste convaincue de l'applicabilité de l'article 218(9) du Traité sur le Fonctionnement de l'Union Européenne et attend avec confiance le jugement de la Cour de Justice dans l'affaire C-399/12 qui devrait probablement être rendu au milieu de l'année prochaine."
