Subject:	Draft amending budget No 8 to the general budget for 2013 - Statement of expenditure by Section - Section III - Commission

- 1. On 26 September 2013, the <u>Commission</u> submitted to the Council draft amending budget (DAB) No 8/2013. It concerns the increase in payment appropriations for the amount of EUR 3.94 billion across headings 1a, 1b, 2, 3a, 3b and 4 of the multiannual financial framework. This DAB is a remaining balance of the DAB 2/2013 adopted by the Council on 9 July 2013.
- 2. The appropriations in DAB No 8/2013 exceed the remaining balance of DAB No 2/2013 by EUR 14.776 million. Therefore, as part of the package including DABs No 6/2013, 8/2013 and 9/2013 and transfer of appropriations DEC 26/2013, the <u>Presidency</u> presented on 8 October to the Budget Committee a compromise proposal suggesting to reduce the Commission proposal by the above mentioned amount. The budget lines proposed for reductions are the following:

- 3. The <u>Budget Committee</u> examined the Presidency proposal at its meeting on 8 October.
- 4. A majority of delegations indicated that the adoption of the Council position on DAB No 8/2013 forms an integral part of the package as proposed by the Presidency and is subject to the European Parliament's approval of the MFF 2014-2020.

Therefore, the <u>Presidency</u> suggests to include, in the Council position on DAB 8/2013, the following text:

- a) a recital stating that "the Council's position is taken in conjunction with the adoption of its position on draft amending budget No 9/2013 and is subject to the European Parliament's approval of the agreement on the multiannual financial framework for 2014-2020";
- b) an additional paragraph in its sole Article stating that "This Decision shall apply from the date of the European Parliament's approval of the agreement on the multiannual financial framework for 2014-2020".
- 5. The <u>Permanent Representative Committee</u> is invited to reach an agreement on DAB No 8/2013, as part of the package as set out in points 2 and 4.
