	- Appointment of Mr Jeremi MORDASEWICZ, Polish member, in place of Ms Małgorzata RUSEWICZ, who has resigned

- <u>The General Secretariat of the Council</u> has been informed of the resignation of Ms Małgorzata RUSEWICZ as member of the above Committee in the employers' representatives category (for Poland).
- Under Article 75 of Regulation (EC) 883/2004 of 29 April 2004<sup>1</sup> which sets up the Advisory Committee for the Coordination of Social Security Systems, members and alternate members are appointed by the Council, whereas by the Council Decision of 21 October 2010<sup>2</sup>, the appointments are valid for a period of five years.

- (2) A seat a member in the employers' representatives category has fallen vacant as a result of the resignation of Ms Małgorzata RUSEWICZ.
