"Regulation (EC) No 562/2006 of the European Parliament and of the Council of 15 March 2006 establishing a Community Code on the rules governing the movement of persons across borders (Schengen Borders Code) is based in particular on Article 62(1) and (2)(a) of the Treaty establishing the European Community, which has now been replaced by Article 77 of the Treaty on the Functioning of the European Union.

According to those provisions, the Union is to develop a policy with a view to, inter alia, ensuring the absence of any controls on persons, whatever their nationality, when crossing internal borders. Article 72 of the TFEU makes it clear that Title V of the TFEU, to which Article 77 belongs, does not affect the exercise of the responsibilities incumbent upon Member States with regard to the maintenance of law and order and the safeguarding of internal security. Thus while the legislative powers of the European Union do extend to regulating the crossing of the internal borders, they do not stretch to the exercise of police powers to maintain law and order and safeguard internal security.

The Federal Republic of Germany therefore expects that the evaluation mechanism will also deal only with whether there really is an absence of any controls when crossing internal borders and not with the exercise of police powers within the territory. The exercise of police powers within the territory falls exclusively within the scope of national sovereignty and is not covered by the evaluation mechanism."

"The Czech Republic holds the view that Council decisions adopted in accordance with Article 218 TFEU throughout the process of concluding the so-called mixed agreements should relate to individual agreements in their entirety. A splitting into two decisions, each of them referring to different articles of an agreement, does not seem to be necessary and could lead to cumbersome procedures.

The Czech Republic notes that the established practice is to conclude only one Council decision relating to an agreement as a whole. With respect to the Case C-377/12 European Commission against Council of the European Union, pending before the Court of Justice of the European Union, we consider the modification of this practice as premature."

<u>The Committee</u> examined the Presidency's compromise proposals included in the above mentioned document, resolved the outstanding issues and agreed to submit it to the TTE Council on 10 October 2013 for adoption.

Furthermore, the Committee agreed to enter into these minutes the following <u>DE</u> statement:

"The Federal Republic of Germany is not opposed to the adoption of the proposed overall compromise for the Regulation amending Regulation (EU) No 912/2010 setting up the European GNSS Agency, but points out that it rejects in principle the European Commission's right to veto the election of the Executive Director of Agencies (Article 5(7)).

There is no provision for any such right of veto in the Common Approach for EU Agencies and it is contrary to the wording of Article 6(4) and the third subparagraph of Article 15b(2) of this Regulation.

The European Commission already has considerable influence in this area, since it draws up the shortlist of candidates for the Executive Director. An additional right to veto the election is therefore inappropriate. The current Agency Regulation (EU) No 912/2010 does not recognise this right of veto either.

The agreement of the Federal Republic to the proposed overall compromise does not represent any change in Germany's position on the Common Approach for EU Agencies and is without prejudice with regard to other agencies."

The <u>Presidency</u> informed <u>the Committee</u> of the main issues addressed at the first informal trilogue which took place on 2 October 2013, namely Broadband targets and financing, where the European Parliament calls for higher targets and a higher percentage of the budget than the Council, and priorities for Digital Services Infrastructure, where the EP would like to put Europeana and Safer Internet for Children as first priority. Besides, some divergence of approach with the Commission regarding governance (role of expert group vs committee) was noted. <u>FR</u> pointed out the inconsistency between a revised proposal with a far reduced budget and little impact on infrastructure projects and the EP's calls for a large percentage of the budget to be devoted to infrastructure.

<u>The Committee</u> will return to this file on 30 October 2013 in preparation of the 2nd and tentatively final, trilogue scheduled on 5 November 2013.
