SCIFA examined at its meeting on 12-13 February 2009 the draft mandate for negotiating a visa facilitation agreement with Cape Verde on the basis of 5918/09 VISA 34 COAFR 38 (RESTREINT).

The Presidency concluded on the basis that, as diverging views had been expressed on the question of proceeding with the mandates at that time, it would be necessary to reflect further in order to establish whether a basis could be found for making progress while taking account of the concerns expressed by delegations.

The group of JHA Counsellors examined at its meeting on 24 March 2009 a number of suggestions made by the Presidency in order to reach a compromise.
