## DRAFT COUNCIL CONCLUSIONS

on Special report No 1/2013 from the European Court of Auditors entitled

"Has the EU support to the food-processing industry been effective and efficient in adding
value to agricultural products?"

## THE COUNCIL OF THE EUROPEAN UNION

- (1) WELCOMES Special Report No 1/2013 from the European Court of Auditors entitled "Has the EU support to the food-processing industry been effective and efficient in adding value to agricultural products?";
- (2) RECALLS that on 17 October 2011, the Commission adopted a proposal for a Regulation of the European Parliament and of the Council on support for rural development by the European Agricultural Fund for Rural development (EAFRD)<sup>2</sup>, aimed at providing, inter alia, a new regulatory framework for EU support to the food processing industry;
- (3) WELCOMES the Commission's reply that the Court's recommendations concerning the exante evaluation of measures, the selection criteria for operations, and the improvement of the common monitoring and evaluation system are reflected in the above proposal, and that steps have been taken to promote the exchange of best practices.
