Subject:	Transfer of appropriations No DEC 26/2013 within Section III - Commission - of the general budget for 2013

1. On 27 September 2013, the <u>Commission</u> presented proposal for transfer of appropriations No DEC 26/2013 ("Global transfer").

The proposed global transfer concerns payment appropriations (p/a) only. It covers a total amount of EUR 509 841 478 and is designed to rebalance p/a for the current budgetary year.

2. On 14 October 2013, as part of the compromise proposal presented by the Presidency, including draft amending budgets No 6/2013, No 8/2013 and No 9/2013, and transfer of appropriations No DEC 26/2013, the Permanent Representatives Committee reached an agreement, by a qualified majority¹, to amend transfer of appropriations No DEC 26/2013. In line with this agreement, and on the basis of the additional information provided afterwards by the Commission on the budget lines for reinforcement, it is proposed to amend the global transfer as follows:
