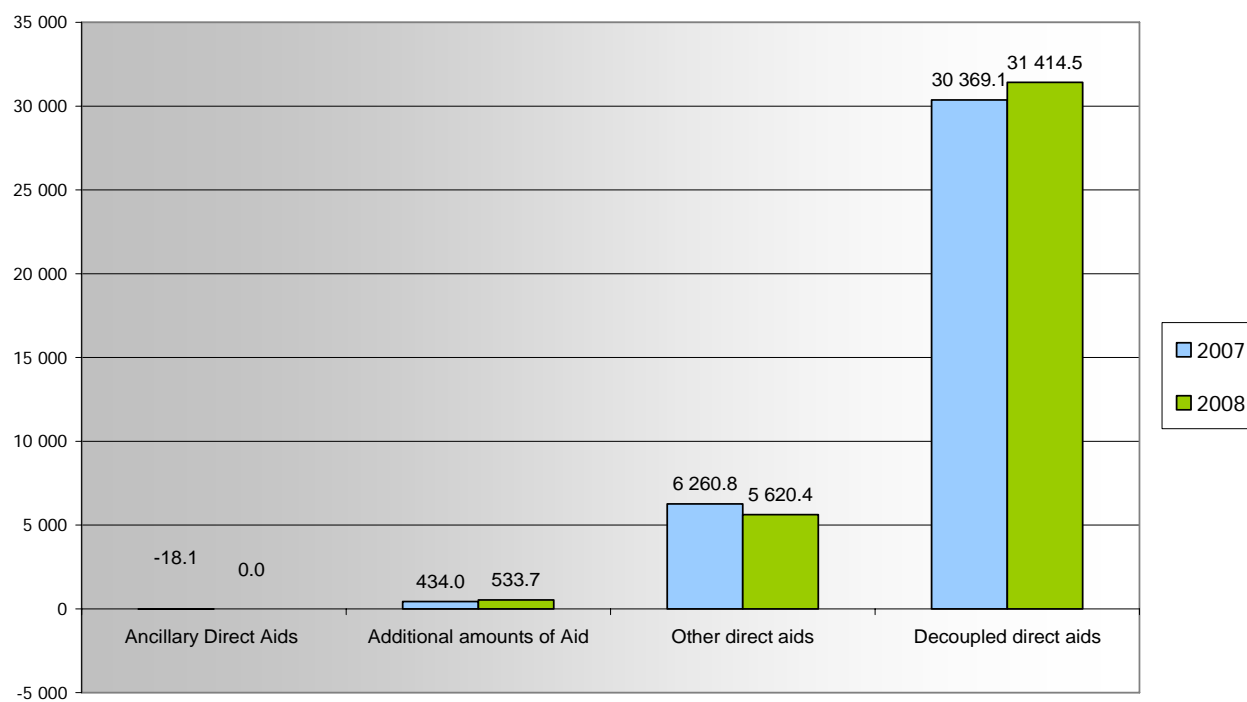

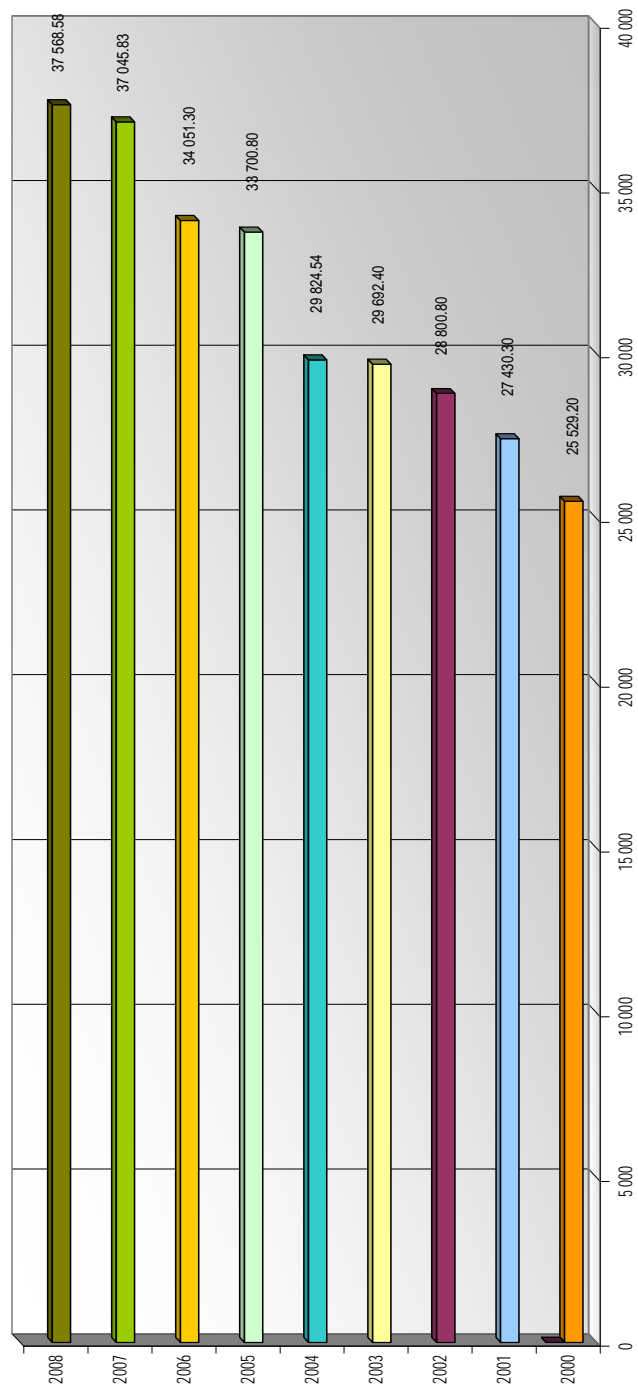

EAGF - EVOLUTION OF DIRECT AIDS EXPENDITURE - 2000 to 2008 Financial years

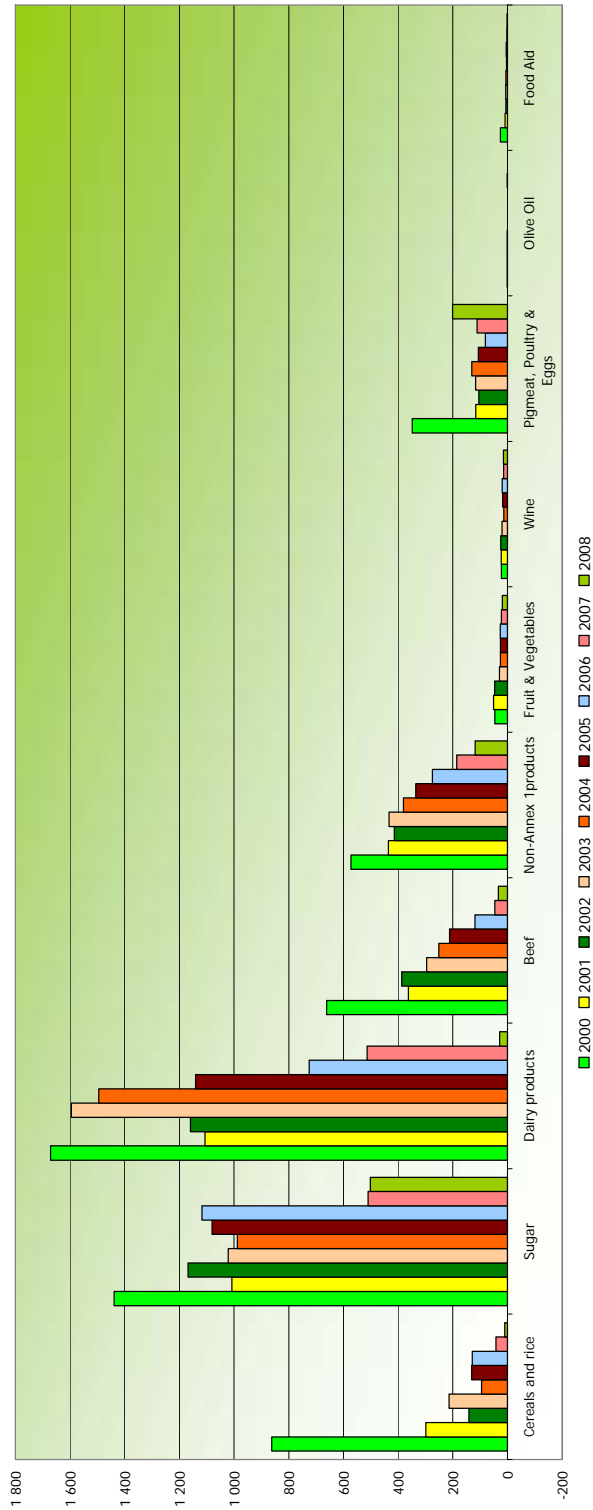

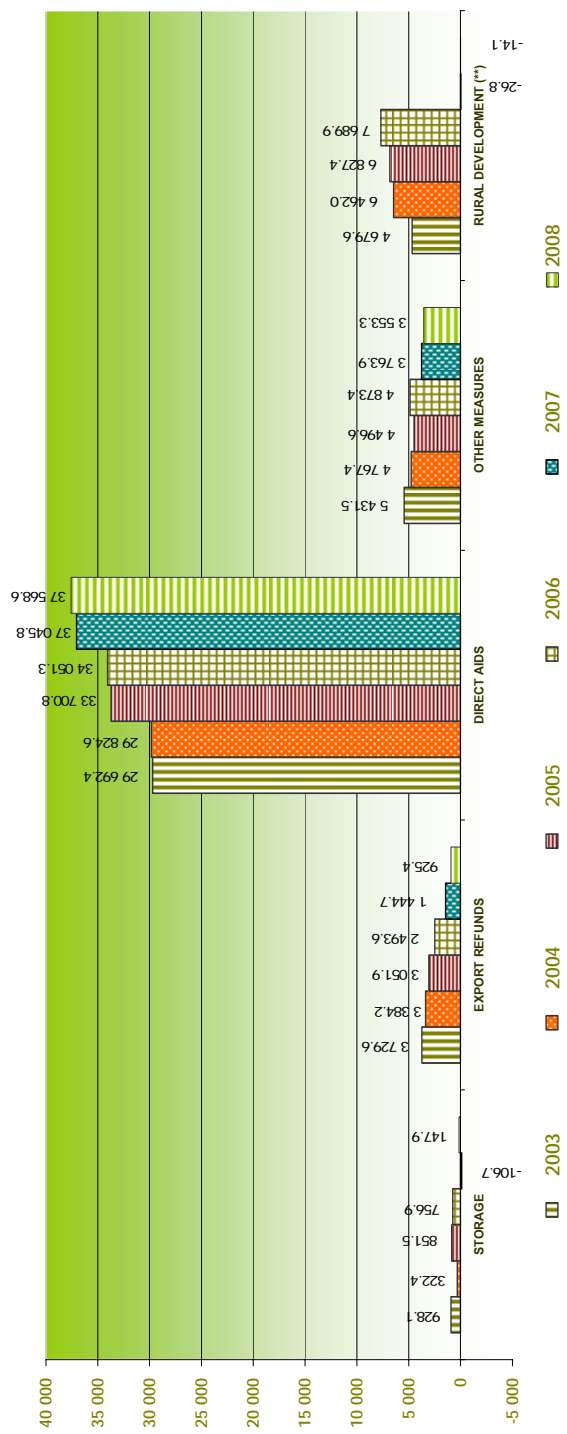
