9219/10 een/ASY/mce 2 DG H 3B **EN** The legal instrument establishing the second-generation Schengen Information System (SIS II), the legal instrument establishing the Visa Information System (VIS) and the instrument establishing EURODAC contain provisions regarding the long-term operational management of those three IT systems. Instead of entrusting the operation of these systems to three independent bodies, the Regulation in question is to create a new European Agency to carry out this task. As the Standing Subcommittee on European Union Affairs previously emphasised in its opinion on the Commission Communication to the European Parliament entitled "An area of freedom, security and justice serving the citizen" (14104/EU XXIV.GP), a high level of data protection and, if necessary, the availability of data protection mechanisms need to be guaranteed if efforts are made to strengthen cross-border data exchange. While this proposal does not concern the establishment of a new database or the extension of an existing one, the joint operation of such systems by a single agency undoubtedly has direct consequences for data protection matters – especially given the purpose of the systems in question and their interoperability. These concerns were dealt with at length in the European Data Protection Supervisor's opinion on the original Commission proposal (OJ L 2010/C 70/13). At the same time, the EDPS made recommendations for allaying them. In the opinion of the Main Committee's Standing Subcommittee on European Affairs, the guarantee of a high level of data protection as mentioned above should be a precondition for implementing these recommendations.

In negotiations in the European Union on a Regulation (EU) of the European Parliament and of the Council on establishing an Agency for the operational management of large-scale IT systems in the area of freedom, security and justice, the competent Federal Government Minister is therefore requested, in the framework of the* by the Commission, to call for the recommendations of the European Data Protection Supervisor to be examined, the matter to be referred to the Data Protection Council and that the National Council be suitably informed.
