Statement by Spain

"The Kingdom of Spain supports the principles underlying the proposal for a Regulation of the European Parliament and of the Council on the rights of passengers in bus and coach transport and amending Regulation (EC) No 2006/2004 on cooperation between national authorities responsible for the enforcement of consumer protection laws.

However, it considers that it would have been preferable for a period of no more than twenty-four hours to be set for the obligation to provide advance notification of the need for assistance for persons with reduced mobility, as it feels that a twenty-four-hour period would be a more favourable one for the assistance to be provided to such passengers, as well as a sufficient period for the bus or coach station manager to be able to plan such assistance."

Statement by the Commission

"The Commission declares that, despite the fact that the political agreement does not entirely meet certain important objectives of its initial proposal, it intends not to oppose this agreement in order to ensure the continuation of the ordinary legislative procedure."

The Council approved its position at first reading, in accordance with Article 294(5) of the Treaty on the Functioning of the European Union (Legal basis: Article 91(1) and 100(2) of the TFEU).

Statement by Greece

"The Hellenic Republic fully and unequivocally supports the aims of the proposal for a Regulation concerning the rights of passengers when travelling by sea and inland waterways, which has special importance for shipping countries, such as Greece, particularly insofar as it strengthens and makes more effective the protection of the rights of the large numbers of passengers travelling each year.

However, the Hellenic Republic wishes to state that, in its opinion, the proposal for a Regulation should show greater balance between the fundamental rights of passengers, which it protects well, and the legitimate interests of sea carriers (especially small and medium-sized enterprises) which, in certain cases (force majeure, exceptional circumstances), incur excessive costs through no fault of their own.

In particular, the Hellenic Republic considers that the exemptions set out in Article 20a (13874/09), and especially in paragraph 3 thereof, should in addition include the obligation to provide accommodation (Article 18(2)) also in the event of exceptional circumstances such as search and rescue operations, transport of sick persons, incidents involving the safety of the ship and passengers and coverage of extraordinary transport needs, which are crucial for the effective functioning of the very extensive Greek coastal network."
