The Council reached, by qualified majority (Poland, Portugal and Slovakia voting against and Romania abstaining), a political agreement on this proposal on the basis of a compromise proposal of the Spanish presidency.

The discussions focused on four issues:

- With regard to the definition of "the member state of affiliation" (in particular the issue of reimbursement of healthcare costs of pensioners living in the EU outside their country of origin and receiving healthcare in a third member state), the Council agreed that the member state competent to grant a prior authorisation according to Regulation 883/2004 (i.e. the member state of residence) reimburse the cost of cross-border healthcare of pensioners. However, if a pensioner is treated in his country of origin, it would be this country that has to provide healthcare at its own expenses.
- Concerning healthcare providers, the agreed compromise ensures that patients looking for a healthcare in another member state will enjoy the quality and safety standards applicable in this country, independently of the type of provider. In addition, the member states may adopt provisions aimed at ensuring that patients enjoy the same rights when receiving cross-border healthcare as they would have enjoyed if they had received healthcare in a comparable situation in the member state of affiliation.
- Concerning the legal basis, the Council agreed on a double legal basis, striking herewith a balance between the case law of the European Court of Justice on the application of Article 114 to health services and the member states' competencies recognized by Article 168 of the Treaty for the organisation and provision of health services.
- As far as e-health is concerned, the ministers agreed on a close collaboration between the member states and the Commission in this field.
