- noted the agreement on the key Articles of the EBA Regulation set out in document 11963/2/10 REV 2 EF 77 ECOFIN 439 SURE 32 CODEC 666;
- invited the Presidency to continue negotiations with the European Parliament on this basis with a view to an agreement on all texts necessary for the Financial Supervision Reform, early enough to permit the new Authorities to begin work from 1 January 2011.

The Council also mandated Coreper to approve minor amendments should this be necessary to reach an agreement with the European Parliament.
