#### **LEGISLATIVE DELIBERATIONS**

#### 3. Preparation for the Conciliation Committee meeting with the European Parliament

<u>The Council</u> prepared its position for the Conciliation Committee meeting with the European Parliament, as provided for in Article 314 TFEU.

It agreed to propose the following draft joint statement on the multiannual financial framework to the European Parliament:

"The present declaration is adopted in full respect of the provisions of the Treaty on the Functioning of the European Union (TFEU) and does not affect the powers conferred on each institution in the Treaties.

In view of the implementation of the TFEU and in full respect of the right of initiative of the Commission, and article 312(2) TFEU, the European Parliament, the Council and the Commission agree to convene regular meetings between the Presidents of the European Parliament, the Council and the Commission, as foreseen by article 324 TFEU on the initiative of the Commission, to promote consultation and the reconciliation of the positions of the institutions.

The institutions reaffirm their willingness to take any measures necessary to facilitate the adoption of the multiannual financial framework as foreseen by article 312(5) TFEU."
