**2. Proposal for a Regulation of the European Parliament and of the Council laying down harmonised conditions for the marketing of construction products**

The Council noted - with qualified majority - its Political Agreement on the text of the proposal as set out in the Annex of document 10163/10. It also noted the statements by the Commission and delegations in Addenda A to F of document 10163/10.

**3. Proposal for a Directive of the European Parliament and the Council on Consumer Rights**

**- Policy debate**

The policy debate focused on the three issues in the Presidency's note.

Vice-President Reding firstly reiterated her intention to achieve progress and real benefits for consumers and traders, as the existing status quo based on minimum harmonisation is not satisfactory, and explore the possibility of targeting harmonisation, on the basis of pragmatic solutions.

A large number of delegations supported the Commission's pragmatic and flexible approach accompanied by an article by article examination in future work instead of trying to agree first on principles.

Concerning the second question, Member States did not support the idea of differentiated legal regimes for contracts concluded on the business premises of the trader (i.e. "on-premises") on the one hand and "off-premises" and distance contracts on the other.

Concerning the question of full harmonisation of information requirements for "off-premises" and distance contracts, the general view was that full harmonisation might be possible with keeping flexibility for Member States in some specifically defined sectors. This would however require further discussion.
