The Council took note of the documents presented by the Commission, of the comments made by delegations and of the initial reaction from the Commission representative.

It mandated its preparatory bodies to launch the detailed examination of the proposal and took note of the information provided by the incoming Presidency with regard to the planned calendar : meetings of the working parties are scheduled for January and March 2011 and an exchange of views is foreseen during the March session of the Council (Agriculture and Fisheries).

The Council mandated the Special Committee on Agriculture to undertake an in-depth examination of the proposals.
