"The Commission has certain doubts that some of the future acts, which the Commission has been given the power to adopt by the legislative act, would be implementing acts. When exercising its implementation powers, the Commission will not adopt, on the basis of the powers granted, acts that it considers as being delegated acts within the meaning of Article 290 TFEU."

Statement by Poland, Portugal and Romania

"Poland, Portugal and Romania regret that the Directive on the application of patients' rights in cross-border healthcare does not provide a sufficient guarantee of a high level of quality and safety to patients wishing to receive cross-border healthcare and does not entirely respect the responsibilities and competences of the Member States in relation to the organisation and planning of national health systems."
