Subject:	Sixth round of mutual evaluations - Observers	

In line with Joint Action 97/827/JHA, adopted by the Council on 5 December 1997, the Working Party on General Matters including Evaluations (GENVAL) decided in the meeting on 22 June 2011 that the sixth round of mutual evaluations will be devoted to the practical implementation and operation in the Member States of the Decisions on Eurojust and the European Judicial Network.

The order of visits to the Member States was adopted by GENVAL on 31 October 2011. This can be found in the Annex to this note, together with the planned starting dates for the missions. The first mission will take place during the first half of May 2012.

The evaluation teams will consist of three national experts, supported by two staff from the General Secretariat to the Council and observers.

In previous mutual evaluation rounds, depending on the subject of the evaluation, observers have been present from the Commission, Eurojust, Europol and, during the 5th round of mutual evaluations on financial investigations and the fight against financial crime, OLAF.

For the 6th round of mutual evaluations, the Presidency suggests that the Commission, Eurojust and Europol are invited as observers. The three have all expressed an interest in taking part in the exercise, and they would all bring added value to the overall exercise.

GENVAL is invited to take note of the planned starting dates for the missions.

GENVAL is invited to agree on the composition of the observer group.
