- 2. Under Article 8 of Regulation (EC) No 2062/94, as amended by Regulation (EC) No 1112/2005, members of the Governing Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EC) No 2062/94 of 18 July 1994 establishing a European Agency for Safety and Health at Work<sup>1</sup>, and in particular Article 8 thereof,

#### Whereas:

- (1) In its Decision of 22 November 2010<sup>2</sup>, 7 March 2011<sup>3</sup> and 21 March 2011<sup>4</sup>, the Council appointed the members and alternate members of the Governing Board of the European Agency for Safety and Health at Work for the period from 8 November 2010 to 7 November 2013.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr Christian DENEVE.
- (3) The government of Belgium has nominated a candidate for the vacant seat,
