13. Follow-up to the Council meeting (Economic and Financial Affairs) on 24 January 2012

The Presidency debriefed about the outcomes of the Council (ECOFIN) meeting and the meetings in its margins:

 During the two intergovernmental ministerial meetings, Ministers:

 First agreed on the text of the Treaty establishing the <u>European Stability Mechanism</u>.
 Then had an exchange of views on the draft text of the <u>Treaty on Stability</u>, <u>Coordination and Governance in the Economic and Monetary Union</u>.

The ECOFIN itself was preceded by <u>breakfast</u>, where:
 Ministers were <u>debriefed from the Eurogroup</u> the day before and had an exchange of views on the <u>economic situation</u>.

- Ministers took note both of the French national preparation of the <u>financial transaction</u> <u>tax</u> (FTT), and of the procedural announcement by the Austrian Minister on the selection process for the new <u>EBRD President</u>.

• Concerning the <u>Council meeting</u>, the Presidency highlighted the following:

- <u>EMIR</u>: The Council updated the negotiating mandate with the European Parliament.

- <u>Economic governance (two pack)</u>: There was a broad majority in favour of the idea of the same reporting standards - issue n° 1. On issue n° 2, the Council had a useful debate, which will be followed in the Working party.

- The Council adopted its decision on <u>Hungary</u> not taking effective action in the excessive deficit procedure.

- The Council took note of the endorsement by 26 Member States of the <u>Code of</u> <u>Conduct</u> with the understanding that the EFC and Commission would review it later this year.

The following statement was made by Slovenia :

Slovenia voted against the entire Code of Conduct in the 24 January ECOFIN Council. The main reasoning behind is that the Code addresses in an imbalanced way the existing excessive explicit liabilities in comparison with the implicit potential future liabilities. Since the Code of Conduct has to be adopted by unanimity of all member states, Slovenia expects this issue to be addressed without delay and stands ready to start working on the issue in a constructive way immediately."

14. Follow-up to the Council meeting (Foreign Affairs) on 23 January 2012

<u>The Committee</u> received a debrief by its President on the follow-up to the FAC. <u>Iran sanctions</u>: Council decision was adopted and published the following day; Commission soon to present a consolidated regulation. Efforts are on-going with partners to mitigate negative effects of oil shortage and ensure security of supply; dual-track also to continue. Burma: suspension of the visa ban.

Syria: support for the efforts of the Arab League.

Support for the planned setting up of a group similar to the Cairo Group for Libya.

Serbia-Kosovo: will be on the agenda of the GAC in February.

Belarus: foreseen rapid adoption of new sanctions, based on new criteria.

Sudan: to be followed up in PSC.

<u>Freedom of Religion</u>: the HR invites proposals in view of the Gymnich, in view of possible reflections in the context of the European Security Strategy (BE, IE: too soon for a revision of the ESS).
