Subject: Governing Board of the European Foundation for the Improvement of Living and Working Conditions
Appointment of Mr Oleg CHULEV, Bulgarian alternate member, in place of Mr Ivan KOKALOV, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Mr Ivan KOKALOV as alternate member of the Governing Board of the above Foundation in the employees' representatives category (for Bulgaria).
2. Under Article 6 of Regulation (EEC) No 1365/75, as amended by Regulation (EC) No 1111/2005, members and alternate members of the Governing Board are appointed by the Council.

3. In accordance with the usual procedure, the employees' organisation ETUC has nominated the following candidate to replace the resigning alternate member for the remainder of the current term of office, ending on 30 November 2013:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EEC) No 1365/75 of 26 May 1975 on the creation of a European Foundation for the Improvement of Living and Working Conditions¹, and in particular Article 6 thereof,

Whereas:

- (1) In its Decisions of 22 November 2010², 7 March 2011³, 14 July 2011⁴ and 22 September 2011⁵ the Council appointed the members and alternate members of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions for the period ending on 30 November 2013.

- (3) The employees' organisation ETUC has submitted a nomination for the vacant seat,

HAS ADOPTED THIS DECISION:

Article 1

Mr Oleg CHULEV is hereby appointed alternate member of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions in place of Mr Ivan KOKALOV for the remainder of the current term of office, ending on 30 November 2013.
