16. Follow-up to the Council meeting (Economic and Financial Affairs) on **21 February 2012**

The President debriefed the Committee on the ECOFIN and the meetings in its margins:

- At the Macroeconomic Dialogue at political level the day before the ECOFIN, the Ministers and social partners discussed the current economic situation and the appropriate policy responses. The key concern was how to ensure growth and jobs in the current juncture.
- At the breakfast before the ECOFIN:
 - Ministers were debriefed from the Eurogroup the day before. The major achievement was the agreement on the second programme to Greece which would reduce the debt to a sustainable level.

Ministers also discussed the <u>economic situation</u> and <u>bank recapitalisation</u>.

- Still during breakfast, Ministers took note of the EIB's intentions for promoting growth.
- On the selection process for the next EBRD President, based on the Austrian announcement, it is foreseen that Ministers will discuss the way forward in the margins of the March ECOFIN.

Concerning the Council meeting itself, the following points were highlighted:

- On economic governance, Ministers agreed on the general approach for the two legislative texts, as well as on the Council statement to be inserted into the Council minutes.
- On macroeconomic imbalances, there was a presentation and first discussion of the Commission's first Alert Mechanism Report. The Council tasked the EFC to prepare Council conclusions on the report for the March ECOFIN.
- On the contribution to the March 2012 European Council, Ministers adopted Council conclusions on macroeconomic and fiscal guidance in the context of the European Semester, and the Member States participating in the Euro Plus Pact adopted conclusions. Bulgaria also submitted a statement on the Euro Plus Pact (tax issues).

- that there is an agreement on the consolidated text of the proposed Regulation as set out in 6925/12 with the opposition of CZ and scrutiny reservation by BE on Article 24.

b) Egypt

First the Committee examined the draft Council conclusions on Egypt as set out in 6694/12, and later reverted to the item by endorsing the text as set out in 6935/12 and submitted it to the Council for adoption.

c) Southern Caucasus

At the request of one delegation, the Committee had an exchange of views on the draft Council conclusions on South Caucasus (doc. 6673/12), which had originally been on the list of "I" items (item 43). The outcome of the discussion on this item is set out in 6934/12.

On this occasion, <u>the Committee</u> agreed to insert in its minutes the following unilateral declarations:

"Declaration of the Netherlands on the Council Conclusions for the Southern Caucasus

The Netherlands emphasize that steps in visa processes are merit-based. As agreed in the Warsaw summit declaration on the EaP of September 2011 visa facilitation and readmission agreements must be concluded and effectively implemented before a decision can be made to take steps towards a visa- free regime. There can be no automaticity.

The Netherlands interpretation of paragraph 13 and 14 in the Council Conclusions is that there remains a strong link between the implementation of visa facilitation and readmission agreements and the EU's commitment to a visa-free regime with Georgia.

Furthermore the Netherlands would like to underline that internal position papers (for examples "lines to take" for Cooperation Councils) do not constitute binding "agreed language" and should therefore not be used as a reference point for Council conclusions."

"Declaration of Lithuania and Romania regarding the Council Conclusions on the South Caucasus

Lithuania and Romania consider that paragraph 22 of the Council conclusions, which refers to the EU engagement policy in the two breakaway regions of Georgia, should be interpreted as having no prejudice to the long standing EU position (as reflected in several EU documents such as 17048/10 and 16656/11) according to which the engagement policies of Georgia and the EU should be mutually reinforcing."

d) Serbia/Kosovo

<u>The Committee</u> briefly considered the handling of this item at the Foreign Affairs Council (FAC) on 27 February 2012. Some delegations raised the question of Croatia's participation in the discussion of this item at the FAC.
