### I. <u>INTRODUCTION</u>

On 27 January 2012, the <u>Commission</u> forwarded to the Council draft amending budget (DAB) No 1 to the general budget for 2012, regarding the financing of ITER. It proposes to incorporate EUR 650 million in commitment appropriations from the margin of sub-heading 1a into Article 08 20 02 (*Euratom - European Joint Undertaking for ITER - Fusion for Energy*) in accordance with the agreement reached between the European Parliament and the Council in December 2011<sup>1</sup>.

# II. OUTCOME OF THE BUDGET COMMITTEE'S PROCEEDINGS

The <u>Budget Committee</u> examined the Commission's DAB No 1/2012 at its meeting on 2 February 2012 and was able to accept it without any changes.

#### III. <u>CONCLUSION</u>

At the close of its examination, the <u>Budget Committee</u> agreed, by a qualified majority<sup>1</sup>, to suggest that the Permanent Representatives Committee advise the Council to:

- adopt the Council's position on DAB No 1/2012 as set out in point II;
- approve the draft decision of the European Parliament and of the Council establishing amending budget No 1/2012 as set out in Annex 1 and transmit it to the European Parliament;
- instruct the Presidency to prepare the budgetary documents to be sent to the European Parliament and to approve the draft letter in Annex 3 to that effect;
- have the Council's position published in the *Official Journal of the European Union* as set out in Annex 2.
