**Operational Action Plan 2012:**  
**Priority Crime Area G: Mobile (itinerant) OC Groups**

**1. Aim**

This Operational Action Plan (OAP) has been created within the framework of the new EU Policy Cycle for organised and serious international crime<sup>1</sup>. Based on the OCTA 2011<sup>2</sup>, Council decided on a total of 8 priority crime areas<sup>3</sup>. This OAP corresponds to the following priority;

*Reduce the general capabilities of mobile (itinerant) organised crime groups to engage in criminal activities*

Subsequently, COSI has adopted strategic goals corresponding to this political priority, for the period 2012-13<sup>4</sup>. This OAP contains a breakdown of all the operational actions that will be carried out during 2012 to achieve these strategic goals. It also gives an overview of the tasking and responsibilities of the Member States and the Agencies involved in the delivery of the plan, in terms of leadership of, or participation in a given operational action.

- Cross-reference between activities which also contribute to a different priority
- Reference (hyperlink) to detailed project documentation for a given activity
- Cumulative progress reporting
