Re: Accession of the Republic of South Sudan to the revised Cotonou Partnership Agreement

On behalf of the Republic of South Sudan, I have the honour to present a request for accession to the Cotonou Partnership Agreement ("the Agreement"), as last revised in 2010 in Ouagadougou, to the ACP-EU Council of Ministers.

South Sudan will shortly begin the procedures required under its Constitution in order to accede in conformity with terms outlined by Article 94 to the Agreement. It is envisaged that this process will be completed by 20 September 2012 at the latest.

Furthermore, in accordance with Article 8 of the Procedure of the ACP-EU Council of Ministers, the Republic of South Sudan would be grateful if the ACP-EU Council of Ministers allowed it to participate as observer in the ACP-EU joint institutions until such time as the Instrument of Accession is submitted.

The Ministry of Foreign Affairs and International Cooperation of the Republic of South Sudan avails itself of this opportunity to renew to the Africa, Caribbean and Pacific Group, as well as the European Union, the assurances of its highest consideration.
