"Declaration by the Republic of Bulgaria and the Czech Republic on the proposal for a Regulation of the European Parliament and of the Council on OTC derivative transactions, central counterparties and trade repositories (EMIR)

The Republic of Bulgaria and the Czech Republic express strong concern about the scope of Article 23 (1) where a recognition of a CCP established in a third country is demanded by ESMA in all cases and for all types of financial instruments, irrespective of whether an obligation for mandatory clearing through CCP is required or not. It would not be allowed under any circumstances a CCP established in a third country to provide clearing services to EU counterparties or trading venues without such recognition and the freedom to choose a CCP on a contractual basis will be restricted in cases where no obligation for central clearing through CCP is required by this regulation or by other EU legislation."

The <u>Commission</u> made a declaration at the same item (11) :

"Declaration by the Commission concerning the proposal for a Regulation of the European Parliament and the Council on OTC derivative transactions, central counterparties and trade repositories (EMIR)

The Commission welcomes the political agreement reached on EMIR, but notes for the minutes that it has legal objections against one provision in the text.

The Commission considers that Article 67a (3) should be deleted.

The Commission is of the view that Article 290 is to be interpreted as meaning that it is autonomous in the preparation and adoption of delegated acts. The standard recital on expert advice contained in the Common Understanding agreed between the three institutions is a reflection of this interpretation. It is therefore not acceptable and is contrary to Article 290 to go beyond the recital as agreed in the Common Understanding and to include an obligation to consult experts in the substantive provisions."

 - "The Republic of Bulgaria has consistently supported the opinion that resolving issues related to the financial and economic crisis requires a coordinated approach at the EU level. The crisis has put national budgets under pressure and has led to challenges for the investment process everywhere in the European Union.
 - The Republic of Bulgaria maintains serious reserve with regard to the proposal for temporary increase in the co-financing rates from the EU funds for the EU Member States which are under financial assistance programmes.
 - 3. The proposed approach discriminates against the Member States which have put extremely important efforts in the years of the crisis to maintain financial and fiscal discipline and have avoided being in a situation of liquidity difficulties. The proposal should have also created incentive mechanisms for the efforts of the Member States which have been disciplined. It should have also encompassed the Member States which stick to financial and fiscal discipline but which because of the economic crisis also undergo temporary difficulties in safeguarding co-financing.
 - 4. The refusal to undertake such an approach may lead to "wrong" incentives to the ones which have not maintained financial and fiscal discipline. The amendment could potentially have a discouraging effect on the Member States in adhering to the Stability and Growth Pact and sticking to sound and sustainable fiscal policy.
 - 5. This position has been expressed by the Bulgarian Prime Minister at the European Council, as well as in the General Affairs Council and ECOFIN. It also has the support of the Bulgarian Parliament."

G20 meeting of Employment Ministers in Mexico, 17-18 May 2012 Representation of EU and Member States

<u>The Committee</u> agreed that the Presidency should be fully engaged and involved, alongside the Commission, in the preparatory meetings and in the ministerial meeting of the G20 Labour and Employment Ministers. It took note of the information provided by the Commission on the preparatory process.

<u>The Spanish delegation</u> inquired about the planned way forward with further work on the CFP reform package and suggested that the debate at the April Council should be properly prepared by <u>the Committee</u> on the basis of non-papers.

<u>The Chair</u> confirmed that Council would hold the orientation debates in April on regionalisation and TFCs and that <u>the Committee</u> would be involved in the preparatory work, but no new texts were expected on these two topics.

2) Timing of CLS opinion on the regulation on measures against third countries

<u>The Spanish delegation</u> inquired about the Council timetable for the proposal for a Regulation on measures against third countries fishing unsustainably, in particular regarding the availability of the legal opinion from the Council Legal Service. <u>The Spanish delegation</u>, <u>supported by the French, Portuguese, Irish, Finnish and United Kingdom delegations</u> stressed that this file is a key priority and all possible means should be used in order to solve the underlying problem with Iceland.

<u>The Chair</u> indicated that the legal opinion was delayed by the late availability of comments from delegations. The Council Legal Service confirmed that the written legal opinion will be available as soon as possible.
