## Whereas:

- (1) On 25 May 2009 the Council authorised the Commission to open negotiations under Article XXVIII of the GATT 1994 with a view to the renegotiation of concessions on poultry meat tariff lines under Chapter 16 of the Combined Nomenclature as provided for in Article 1 of Council Regulation (EEC) No 2658/87 of 23 July 1987 on the tariff and statistical nomenclature and on the Common Customs Tariff<sup>1</sup> ("CN").
- Those negotiations resulted in Agreements in the form of exchanges of letters initialled with Thailand on 22 November 2011 and with Brazil on 7 December 2011 (hereinafter "the Agreements").
- (3) In accordance with Council Decision No .../2012/EU of ...\*<sup>2</sup> the Agreements were signed on behalf of the Union on...\*\*
- (4) The Agreements should be approved,
