Subject: Management Board of the European Institute for Gender Equality:
- Appointment of Ms Judit HALASZ, Hungarian alternate member, in place of
Ms Anna OROSZ, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Anna OROSZ as alternate member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Hungary).
2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006¹ provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

3. The eighteen members and alternate members appointed by the Council represent eighteen Member States in the order of the rotating Presidencies, one member and one alternate member being nominated by each Member State.
4. The Government of Hungary has put forward the following candidate to take the place of the alternate member who has resigned, for the remainder of the current term of office which ends on 31 May 2013:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EC) No 1922/2006 of 20 December 2006 establishing the European Institute for Gender Equality², and in particular Article 10 thereof,

Whereas:

- (1) By its Decision of 18 May 2010³ the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2013.
- (2) An alternate member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Anna OROSZ.
- (3) The Government of Hungary has submitted a nomination for the vacant seat,

HAS ADOPTED THIS DECISION:
