In view of the forthcoming submission by the Commission of its Cohesion Package, <u>the Council</u> held a comprehensive debate on the future role of the European Social Fund (ESF) in the framework of the EU 2020 Strategy, based on a Presidency background paper (14224/11).

The Council discussions concentrated on the following questions :

- how the ESF could contribute to the implementation of the EU 2020 objectives and headline targets in the areas of employment, educational attainment, social inclusion and poverty reduction;
- the goals of the various flagship initiatives to which the ESF should provide priority support;
- how to reorient the ESF towards a more result-based approach and how to simplify procedures, in particular for the beneficiaries;
- possible ways for actors at EU, national, regional and local levels, to improve the effectiveness of the ESF and how the ESF could be made more efficient in delivering on these targets.
