# Declaration of the Estonian Republic in accordance with Article 2(3) of the Council Decision 2008/615/JHA

#### List of shared national DNA files

The national DNA database is based on the CODIS (Combined DNA Index System), which is installed at the Estonian Forensic Science Institute. CODIS was first installed in Estonia in 2002 by officers of the FBI (United States).

The Estonian Forensic Science Institute is able to share DNA profiles with other European countries. The following types of profiles will be made available to other countries:

- Forensic unknown: genetic profile obtained from a specimen of unknown origin unidentified generally a specimen obtained from evidence associated with a criminal act.
- **Suspect known**: genetic profile obtained from a specimen of known origin fully identified from a suspect (arrestee, convicted offender etc.).

## Conditions governing the exchange and comparison of profiles

A country that wants to carry out the exchange and comparison of profiles with the Estonian Republic must comply with the legal, organisational and technical requirements laid down in Council Decisions 2008/615/JHA and 2008/616/JHA of 23 June 2008, in particular:

- Technical requirements: the country must:
  - have an automated national DNA database;
  - have automated means of exchanging profiles;
  - be connected to the TESTA network:
  - have confirmation from a country that is already operational, that its exchange system is adequate.
- Legal requirements: the country must:
  - be able to share information under its domestic legislation;
  - comply with European rules on the processing of personal data;
  - have the Council's prior authorisation to exchange data.
- Organisational requirements: the country must:
  - have a national contact point to which Estonia may apply for additional information further to a DNA profiles match.
