Having first recalled his intention to proceed on the basis of a broad mandate with the shared understanding that what the European Council is calling for is an agreement with the European Parliament by the end of June the Chair outlined the key principles for this mandate and the main changes brought to the text (doc. 7659/12). The Commission agreed with the Presidency approach as well as with the key principles set out in 7659/12 while noting that the current text would close only 1/3 of the gap to the 20% target. Following the comprehensive exchange of views conducted then by the Committee the Chair concluded that delegations could give their broad support to a mandate allowing the Presidency to enter into discussions with the European Parliament, on the occasion of a first informal trilogue of an exploratory nature, on the basis of the 11 key principles set out on p. 3 of 7659/12 and on the preliminary position set out in 7659/12, while being aware of remaining difficulties here and there. It was also noted that a significant amount of technical work needs to be carried out, which will be done in parallel with discussions with the European Parliament.

While all comments and suggestions were duly recorded and overall consistency of dates and time periods has to be further checked, without prejudice to considering other changes the Presidency noted that changes could be reflected in the preliminary Council position in particular concerning Art. 3 (reference to primary and/or final energy consumption), Art. 4 (innovative financing, reference to "owned and occupied" buildings), Art. 6 (gradual phasing-in of the target, handling of ETS-covered activities, cut-off date for early actions, further work on additionality), Art. 10 (threshold for CHP) and Art. 19 (alignment of reporting dates).

The Chair presented the agenda of the next JHA Council to be held on the 26 and 27 April 2012. The Commission requested a change in the order of the items on Friday 27th, HU asked for the introduction of an AOB item on the commemoration of victims of totalitarian regimes, and several other delegations (FI,HU,RO,BG,AT) made suggestions for items on the agenda. The Presidency considered that the multiannual framework of the Fundamental Rights Agency suggested by FI is not ready for discussion in April and that it will reflect on the inclusion of the Roma national strategy.

<u>The Committee</u> reached agreement and gave a negotiating mandate to the Presidency to enter into informal trilogue with the European Parliament on the basis of the positions set out in 8293/12. <u>The Committee</u> took note of the following declarations of Sweden and the Netherlands and the statement of the Commission:

"Declaration by Sweden regarding Article 9(1)(b) of the draft Regulation of the European Parliament and of the Council applying a scheme of generalised tariff preferences

Sweden does not intend to object to the proposal by the Presidency, but would like the following declaration on its legal position taken to the record of the proceedings.

"Sweden declares that the position of Sweden to the proposed amendments to the Regulation of the European Parliament and of the Council applying a schema of generalised tariff preferences, and especially Article 9.1b thereof, shall be without prejudice to Sweden's legal position regarding reservations to treaties and the legal effect of invalid reservations. Sweden would like to underline that according to the Vienna Convention on the Law of Treaties (and confirmed by State practice) a reservation that is contrary to the object and purpose of the convention is to be considered null and void. As such the reservation is without legal effect. Sweden, and a growing number of states, have developed a practice of severing invalid reservations from the treaty relation between the States concerned. Instead of excluding bilateral treaty relations entirely when objecting to invalid reservations, the option of severability secures bilateral treaty relations and opens the possibility of dialogue within the treaty regime. In line with this a convention to may enter into force in its entirety without the reserving state benefitting from its reservation.

In addition, Sweden would like to underline that any state party to a convention has the right to evaluate reservations made.""

"Declaration by the Netherlands related to article 9(1)(b) of the draft Regulation of the European Parliament and of the Council applying a scheme of generalised tariff preferences

The position of the Netherlands to the proposed amendments to the Regulation of the European Parliament and of the Council applying a scheme of generalised tariff preferences, and especially Article 9.1b thereof, shall be without prejudice to the Netherlands' position regarding the law on reservations to treaties and the legal effect of invalid reservations."

"Statement by the Commission

As per paragraph 4 of the Common Understanding, the Commission, when preparing and drawing up delegated acts, will ensure a simultaneous, timely and appropriate transmission of relevant documents to the European Parliament and the Council and carry out appropriate and transparent consultations well in advance, including at expert level."

42. Presentation of the provisional agenda for the Council meeting (Foreign Affairs) on 23 April 2012

<u>The Committee</u> received a presentation by ESG Pierre Vimont on the provisional agenda of the Foreign Affairs Council on 23 April 2012.

Main items: **Burma/Myanmar** (following by-elections on 1 April, Ministers will discuss a way forward, in particular as regards the review of restrictive measures, Council conclusions to be adopted); **BIH** (assessment of the implementation of the EU strategy towards BIH, discussion on a way forward in particular as regards the SAA, EU membership application and reinforced EU presence, no Council conclusions foreseen); **Afghanistan** (with a view to the NATO Chicago Summit discussion on Afghanistan beyond 2014, the HR will aim an coordinated EU approach); **Syria** (follow up of the Friends of the Syrian people meeting in Istanbul on 1 April, state of play of the implementation of the Anna Plan for ceasefire, humanitarian situation and the activities in the UN).

During lunch, Ministers will discuss the **Middle East** and the state of play of **nuclear negotiations with Iran**.

The FAC should start at 10 am, and should normally end with the lunch.

43. Follow-up to the EU-Republic of Korea Summit (Seoul, 28 March 2012)

The EEAS and the Commission debriefed <u>the Committee</u> on the results of the EU-RoK Summit held in Seoul on 28 March 2012.

The Summit concentrated on the following issues: bilateral relations, global economy and Democratic People's Republic of Korea. It was a short, good and consensual meeting that reaffirmed the new Strategic Partnership with Korea and acknowledged the political cooperation in existing and new areas, including on human rights, international development, anti-piracy. Both sides agreed to further strengthen cooperation in trade, climate change, education, science and technology.

The Committee would come back to this issue in late May, with a view to an A item at the June General Affairs Council. The Chair highlighted the methodology and the Presidency approach set out in the Note to the Committee and stressed the coordinating role of the Friends of the Presidency approach, with a view to the timely adoption of the instruments. The Commission underlined the importance of flexibility. No delegations took the floor.
