	Appointment of Mr Alexandru ALEXE, Romanian member, in place of Mr Sorin Ioan BOTEZATU, who has resigned

- 1. <u>The General Secretariat of the Council</u> has been informed of the resignation of Mr Sorin Ioan BOTEZATU as member of the Governing Board of the above Foundation in the government representatives category (for Romania).
- Under Article 6 of Regulation (EEC) No 1365/75, as amended by Regulation (EC) No 1111/2005, members and alternate members of the Governing Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Romania has nominated the following candidate to replace the resigning member for the remainder of the current term of office, ending on 30 November 2013:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EEC) No 1365/75 of 26 May 1975 on the creation of a European Foundation for the Improvement of Living and Working Conditions<sup>1</sup>, and in particular Article 6 thereof,

Whereas:

(1) In its Decisions of 22 November 2010<sup>2</sup>, 7 March 2011<sup>3</sup>, 12 July 2011<sup>4</sup> and 20 September 2011<sup>5</sup> the Council appointed the members and alternate members of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions for the period ending on 30 November 2013.

- (3) The government of Romania has submitted a nomination for the vacant seat,

HAS ADOPTED THIS DECISION:

## Article 1

Mr Alexandru ALEXE is hereby appointed member of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions in place of Mr Sorin Ioan BOTEZATU for the remainder of the current term of office, ending on 30 November 2013.
