I. <u>INTRODUCTION</u>

On 16 March 2012, the <u>Commission</u> forwarded to the Council draft amending budget (DAB) No 2 to the general budget for 2012, regarding the mobilisation of the EU Solidarity Fund for a total amount of EUR 18 061 682 in commitment and payment appropriations. Its objective is to provide a financial assistance to the regions of Liguria and Tuscany in Italy, affected by heavy rainfall and flooding in October 2011.

The corresponding appropriations are to be recorded under Article 13 06 01 (*EU Solidarity Fund - Member States*).

In a letter dated 20 April 2012, the Commission informed about the expected underimplementation of payment appropriations related to Energy projects to aid economic recovery and proposed to use the available amount inter alia to finance the mobilisation of the EU Solidarity Fund related to flooding in Italy.

II. OUTCOME OF THE BUDGET COMMITTEE'S PROCEEDINGS

The <u>Budget Committee</u> examined the proposal for DAB No 2/2012 at its meetings on 27 March, 23 April and 3 May 2012.

Following its examination, the Budget Committee agreed, by qualified majority¹, on the Presidency proposal to use the possibility for redeployment suggested by the Commission to cover the corresponding appropriations and to transfer EUR 18 061 682, in payment appropriations, from Item 32 04 14 01 (Energy projects to aid economic recovery - Energy networks) to Article 13 06 01 (EU Solidarity Fund - Member States).

III. CONCLUSION

The <u>Permanent Representatives Committee</u> is invited to advise the Council to:

- adopt the Council's position on DAB No 2/2012 as set out in point II;
- approve the draft decision of the European Parliament and of the Council establishing amending budget No 2/2012 as set out in Annex 1 and transmit it to the European Parliament;
- instruct the Presidency to prepare the budgetary documents to be sent to the European Parliament and to approve the draft letter in Annex 3 to that effect;
- have the Council's position published in the *Official Journal of the European Union* as set out in Annex 2.
