1. The General Secretariat of the Council has been informed of the resignation of Ms Tatjana ČERIN, as member of the above Committee in the employers' representatives category (for Slovenia).
2. Under Article 27 of Regulation (EEC) No 1612/68 on freedom of movement for workers within the Community, members and alternate members are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 1612/68 of 15 October 1968 on freedom of movement for workers within the Community¹, and in particular Articles 26 and 27 thereof,

Whereas:

- (1) In its Decisions of 21 October 2010² and 21 March 2011³, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2012.
- (2) A seat as member in the employers' representatives category has fallen vacant as a result of the resignation of Ms Tatjana ČERIN.
- (3) The Government of Slovenia has submitted a nomination for the vacant seat,
