The Committee agreed the provisional agenda for the forthcoming Council meeting (Agriculture and Fisheries) on 14 and 15 May 2012 as set out in 9667/12.

- Presidency debriefing on the outcome of the informal trilogue**

The Presidency informed the Committee on the results of the first informal trilogue on the railway recast, held in Brussels on 23 April 2012.

- Presidency debriefing on the outcome of the informal trilogue**

The Chair debriefed the Committee on the 2nd informal trilogue which took place on 23 April 2012. On this occasion the rapporteur expressed his satisfaction with the Council text on Art. 5 while pointing out the three issues where the European Parliament would like further movement, namely the inclusion of commercial agreements (Art. 3), information to the Commission before and during negotiations (Art. 3 and 4), and the review (Art. 8). In reply the Chair reiterated the Council's red lines on the first two issues while stating that the third one is the only area where the Council could possibly improve its offer if this could lead to an overall agreement.

The Commission representative explained that the Commission had little interest in developing the review clause as this would increase the administrative burden without adding substance and would prefer progress on the two other issues. Regarding commercial agreements Commission is not interested in these agreements as such only in legal provisions included there that may affect the internal market.

The Committee will return to this proposal on 4 May 2012.

**- Presidency debriefing on the outcome of the informal trilogue**

The Chair debriefed the Committee on the 2nd informal trilogue which took place on 24 April 2012. The trilogue went through Art. 7, 8, 11 to 15 as well as Art. 8a and 13a proposed by the European Parliament, where the new elements tabled by the Council were in broad terms well received by the EP although the EP side, insofar as the rapporteur presented its position, did not show any significant flexibility in return and largely repeated its position on these provisions. In light of the discussion the Commission volunteered to provide contributions on a series of provisions e.g. on simplified Annexes Va and VI, on the articulation between internal market legislation and ongoing standardisation work on smart meters and Art. 8 (metering), and on demand-response although it should be clear that the Council is not demandeur on provisions in this respect.

The Chair also reported on the messages that the Presidency brought back from the informal energy Ministerial (Horsens, 19-20 April), in particular delegations' support for reaching agreement by the end of June on an ambitious but flexible Directive.

The Committee will return to this proposal on 4 May 2012 with a view to preparing the next trilogue scheduled on 8 May 2012. The Presidency's intention is to have the Committee handling this proposal in a "DPR + 1 + Mertens" format while giving more focused tasks to the Working Party ENER.

The Committee examined the proposed goals and targets (Annex I) and decided that the text needed further work by experts before it could be considered as agreed for the purposes of outreach and consultations with third parties. The Committee also considered that this text should not be presented as an agreed EU position or a basis for negotiations in New York, but rather as an indicative or illustrative example of what the EU has in mind in terms of concrete goals and targets in the context of an inclusive green economy.

#### 47. Follow-up to the Council meeting (Foreign Affairs) on 23 April 2012

The Committee received a presentation by MD Mara Marinaki on the follow-up to the Foreign Affairs Council on 23 April 2012. It was noted that between this last FAC and the next one on 14 May 2012 (FAC-Development) there are only 11 working days.

**Burma/Myanmar:** agreement to suspend the sanctions, review in October. The real milestone will be the elections in 2015. The HR/VP is visiting the region, donor coordination to be followed up at the May FAC-Development.

**Afghanistan:** need to agree on a clear line in view of the Chicago conference, Council conclusions foreseen in the May FAC.

**Africa:** South Sudan and Mali (on the latter, agreement to start listing in view of restrictive measure).

Issues raised under AOB: Argentina, Libya (to be taken up again in May), Belarus, Surinam (Art. 8).

Items discussed over lunch: Syria, Iran, MEPP (to be taken up at the May FAC, with a number of Member States expressing strong support for an in-dept and formal discussion on this item).

Solidarity was expressed by the FMs to DK regarding the serious situation of human right activist al-Khawaja, a dual-national imprisoned in Bahrain.

#### 48. Presentation of the agenda of the Council meeting (Foreign Affairs/Development) on 14 May 2012

The agenda will be very dense and will include:

**Afghanistan:** follow-up and Council conclusions on the NATO Chicago Summit, the Kabul regional conference and the Tokyo donors conference.

**MEPP:** debate in the informal session, need to find the highest common denominators on area C issues, Council conclusions foreseen.

**South Neighborhood** also to be discussed: Libya, Syria, Algeria, possible Council conclusions.

**Mexico:** in view of the Summit on 16 June 2012.

**Russia:** in view of the Summit on 3-4 June 2012 (strategic reflection).

**Ukraine:** in view of the adoption of a general approach on the Association Agreement.

**Bosnia and Herzegovina:** postponed from the April FAC.

**The Development segment** will start at 17hrs and will comprise discussions on two Commission Communications:

(1) Agenda for change (sustainable growth and Human Rights and Governance);

(2) budget support; Council conclusions foreseen on both items.

Also on the agenda: **Burma/Myanmar:** follow up of the April discussions, how to best phase in on development, debrief of the HR visit in the area.

Under the AOB: Food Security in the Horn of Africa and Policy coherence for Development (possible Council conclusions on both).

A few requests of additional items by Member States, EEAS will follow-up:

Discussion on the external dimension of Energy policy (will possibly take place at July FAC) (DE/RO); discussion on Pakistan (EEAS confirmed that HR/VP is preparing a trip in the country) and Somalia (UK); Rio+20 (FI); Serbia and Kosovo (SI); possible postponement of BiH to June.

UK would like to brief Foreign Ministers on "International Family Planning", event to be hosted by the UK together with the Gates Foundation on 11 July; FR would like to have an update on "Joint programming".
