Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003¹ on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- (1) In its Decisions of 16 February 2010², 22 March 2010³, 29 March 2010⁴, 19 April 2010⁵ and 21 March 2011⁶ the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2013.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr Mauro FRANCIOSI.
- (3) The government of Italy has nominated a candidate for the vacant seat,
