"The Commission notes that its position is not correctly recorded in the Presidency progress report and recalls its reservations on the debate so far on a number of issues listed under point V, in particular on the Commission's power to adopt delegated acts and the exclusion of correlation tables, which should be rather listed under point VI among the main outstanding issues."

Statement by the Commission

"The Commission notes that the Presidency progress report does not correctly reflect its position as expressed in the discussions in Council bodies and recalls the importance of respecting the correct modalities for external representation of the Union as set out in the Treaty and as reflected on the basis of its original proposal and does not share the view that there is a joint responsibility for the participation of the Union in the Rotterdam Convention on Prior Informed Consent as referred to in the progress report from the Presidency."

Statement by the Council

"The tariff suspension related to dried and sweetened cranberries shall be reviewed before the end of 2012. The Council requests the Commission to assess the methods to be followed in order to guarantee the proper use of the imported goods benefitted from the tariff suspension. In this regard, the Commission is invited to elaborate a questionnaire to be filled in by the national Customs Administration, in view of a discussion to be hold in the Economic Tariff Questions Group, during the second quarter of 2012. The Commission shall report the results of this discussion to the Working Party on Customs Union in September 2012 at the latest."

The Commission made a statement as set out hereafter.

Statement by the Commission

"The Commission attaches high importance to the effective integration of biodiversity into the key sectoral policies. The EU Biodiversity Strategy to 2020 includes specific integration targets and actions, in particular in relation to agriculture, forests and fisheries. As stated by the Council over the past two years, further integrating and mainstreaming biodiversity into all relevant policies needs to be significantly strengthened, particularly considering the benefits that biodiversity and ecosystem services provides for a large number of sectors.

Maintaining and restoring agriculture and forest biodiversity is a precondition to attain our biodiversity objectives. Therefore, the Commission can only regret the absence of ambition of these conclusions on agriculture integration. More specifically, the Commission regrets the deletion of all concrete indications on the required way forward to strengthen the contribution of the Common Agriculture Policy to biodiversity objectives.

As highlighted in its proposals on the reform of the Common Agriculture Policy, the Commission reiterates the importance for biodiversity of maintaining permanent grasslands; of protecting and supporting Ecological Focus Areas; and of ensuring crop diversification; and emphasises in this context the importance of action at farm level. The Commission further underscores the importance of incorporating biodiversity elements – in particular in relation to Natura 2000, High Nature Value farming and the protection and restoration of wider biodiversity – into rural development, and of recognising the value of ecosystem services provided by farmers. These priorities will continue to guide the Commission's position in inter-institutional discussions on the reform of the Common Agriculture Policy."
