The Committee set the provisional agenda for the meeting of the Competitiveness Council on 30 and 31 May 2012.

The Committee agreed to a Presidency mandate with a view to the third and last informal trilogue to be held on 15 May 2012 in the framework of negotiations with the European Parliament to reach an agreement in first reading on the proposed Directive.

The Committee completed the partial mandate agreed on 17 April 2012 by reaching agreement, by qualified majority, on the missing Articles 8, 11, 13, 17 as well as on recitals 5a and 21 and Articles 9, 10(2) and 12. <u>DE</u> was opposed to the new Articles.

The Chairman debriefed the Committee on the 3rd trilogue which took place on 9 May 2012. He expressed his disappointment at the way the European Parliament side operated at this trilogue which was supposed to be the last one while the EP was not able to agree to the Council offer, which the Commission could accept, and called for an additional trilogue. At the trilogue the Chairman made it clear that should the EP not be in a position to accept the Council text there might be no majority in Council for the Council to conclude its first reading. In the end the EP asked for a two-week reflection period in order to consider its final position.

The Committee could agree to the text as set out in 9653/12 and to its sending to the European Parliament

The Chairman debriefed the Committee on the 3rd trilogue which took place on 8 May 2012 and noted the generally constructive atmosphere in which it took place as reflected in the solid progress made on Art. 12 to 15 while on Art. 7, 8 and 8a additional technical work is needed.

9651/12 11 DOPG EN He also noted the Commission's valuable contribution to this progress. The trilogue was also the occasion of a more "political" exchange of views on Art. 3, where the well-known diverging positions of the European Parliament and Council on binding targets were reiterated; 6, where the Chairman outlined a possible approach to flexibility; 10, where discussion on the decision-rule for investment took place and 19 in relation with the ETS (set-aside) issue, where the Council side reiterated its objection to amending the ETS.

The Chair stressed the amount of work still required to complete the negotiations in time as well as the need for a higher level of ambition.

The next trilogue will take place on 29 May 2012 and be prepared on 23 May 2012.

<u>The Committee</u> received an update from the Commission on its talks with the Russian Federation and the US on the outstanding issue of EU representation on the Green Climate Fund Board. There was not yet a breakthrough but the Commission expressed the hope that the issue could be resolved since no matters of principle had been raised in those bilateral contacts.

<u>The Committee</u> reached agreement on the text of Council conclusions nominating an EU representative from the Commission to sit on the Board of the Green Climate Fund. These conclusions would be submitted to the Council (Ecofin) on 15 May 2012 with a view to their adoption as an A-point.

<u>The Presidency</u> emphasised that in the subsequent submission of developed countries to the UNFCCC Secretariat / interim secretariat of the Green Climate Fund, it would need to be made clear that the submission was being made without prejudice to the resolution of the outstanding issue of EU representation on the Board. It added that this submission would need to be made as soon as possible in order to avoid the risk of a new postponement of the first meeting of the Board on 31 May - 2 June 2012.

Following a discussion on three selected outstanding issues, <u>the Committee</u> invited the JHA Counsellors to refine the text of the draft Directive with a view to presenting a 'compromise package' at a next session of <u>the Committee</u>, so as to allow the Council (JHA) to reach a general approach on the text at its meeting on 8 June 2012.

The Committee approved the Presidency approach on the reform of the Statute of the Court of Justice, including splitting of the Court's requests, on the basis of a Presidency note set out in 9571/12. It approved, as a first step, a mandate for negotiations with the European Parliament with a view to a first reading agreement on those parts of the Court's requests not linked to increasing of the number of Judges of the General Court, while the Council would remain to be seized of the other parts of the Court's request.

On the basis of a draft mandate to be presented at a later stage, the Committee would examine the possibility of taking forward reflections in the framework of the Friends of the Presidency Group, with a view to identifying solutions to address the General Court's backlog in time for the partial renewal of that Court in September 2013.

The Committee discussed the final draft Rules of Procedure of the Court of Justice (recast), as set out in 9572/12. Following an exchange of views with the representative of the Court of Justice, the Presidency invited the Court of Justice to continue reflections on Article 100(1) of the draft Rules of Procedure on the circumstances in which the Court remains seized of a reference for preliminary ruling.

The Committee agreed by qualified majority the draft mandate set out in the fourth column of document 9441/12 with the following modifications:

- Article 4a, paragraph 1: "Access to legal advice relating to issues which are the subject of a decision-making process until the relevant act becomes definitive or regarding a question of law which has not been decided, in last instance, by the Court of Justice, shall be presumed to undermine the protection of legal advice. The applicant may demonstrate that there is an overriding public interest justifying the disclosure of the documents.";
- Article 4a, paragraph 3: "For the purpose of this article, the principles underlying this regulation do not in themselves constitute such an overriding public interest.".

SE delegation did not agree with the contents of the mandate, as set out in 9441/12, and made the following statement:

"The compromise text would lead to less transparency in the EU. Hence, Sweden cannot endorse the text."

EE, FI and NL delegations aligned themselves to this statement.

EEAS ESG Vimont debriefed on the agenda of the FAC of 14 May 2012. Ministers will discuss Afghanistan, Middle East Peace Process (MEPP), Southern Neighbourhood with particular focus on Syria, Libya and elections in Algeria, and EU relations with Mexico. Pakistan, BIH and Iran items have been withdrawn from the agenda. It has also been decided that external aspects of the EU energy policy will be discussed at the June FAC. FAC will aim to adopt conclusions on Somalia, Yemen, MEPP, Afghanistan and Syria.
