Union and its Member States and the Republic of Moldova

Adoption

COMMON GUIDELINES Consultation deadline: 6.6.2012

1. This draft Agreement is the result of the mandate granted by the Council to the Commission on 16 June 2011, to open negotiations with the Republic of Moldova for establishing a Common Aviation Agreement. On the basis of this mandate, the Commission concluded the negotiations successfully and the draft Agreement was initialled on 26 October 2011.

- 2. On 27 January 2011, the Commission submitted to the Council a proposal for a Council Decision on the signature of the Common Aviation Agreement between the European Union and its Member States, of the one part, and the Republic of Moldova, of the other part (doc. 5922/12). The text of the above draft Council Decision, including the draft Agreement was examined by the Aviation Working Party.
- 3. Following the comments made by delegations, the Presidency, after consultation with the Council Legal Service, has proposed to follow the established practice of the Council and to modify the draft Council Decision in order to involve Member States' representatives in the adoption process and thereby also making Member States' competences apparent in the context of this mixed agreement. Clarifications on the establishment of the Union positions within the Joint Committee set up by the Agreement have also been introduced. The compromise text was examined by delegations, adjusted in light of their comments and, thereafter revised by the Legal Linguistic Services¹.
- 4. Following the examination of the above text, COREPER could invite the Council to:
 - adopt the above draft Decision of the Council and of the Representatives of the Member States meeting within the Council, as well as the attached draft Agreement as they appear in documents 8181/12 and 8185/12, so that the signature and the provisional application of the Agreement can proceed;
 - include in its minutes the statement by Finland as set out in the Annex to this Note.
