Regarding item 5, <u>IE</u> stated that it could not support the mandate for this negotiation as it had difficulties accepting the scope. Ireland stated that it should be possible to move closer to the position of the European Parliament on the issue of scope.

## 6. Decision to appoint 7 members of the Management Board of the European Food Safety Authority

The item was briefly introduced by <u>the Presidency</u> who explained the proposed procedure (doc. 9736/12). Despite a number of complicating factors he invited delegations to share the Presidency's pragmatic approach so as to allow EFSA to function normally without delay. Regarding the recent resignation of the Chair, he suggested that the Commission launches a separate call to replace her.

<u>The Commission</u> supported the Presidency proposal and emphasized that the list of 14 candidates had been drafted following the criteria already used in the past. They also pointed out that launching a new procedure would be extremely time consuming.

<u>A number of Member States</u> feared for EFSA's credibility and voiced several concerns. However, with a view to ensure a fully functioning management board, a <u>large majority</u> was ready to support the Presidency pragmatic proposal.

The Presidency therefore concluded that he would launch a written procedure to ask each Member State to cast its vote on 7 candidates out of the 14 present in the list. The list so created will then be submitted to Council for final adoption by qualified majority before the deadline of 30 June 2012. In addition, a declaration by the Council could be adopted reminding the Commission to ensure that the future 2014 list of candidates contains a sufficient number of candidates having a background in organisations representing consumers and other interests.

### 21. Follow-up of the Council meeting (Economic and Financial Affairs) on 15 May 2012

The Committee took note of the proceedings of this Council meeting.

The ECOFIN Council was preceded by the Annual EIB Governors meeting.

During the breakfast, Ministers were debriefed from the Eurogroup the day before and had an exchange of views about the economic situation. The President of the EFC informed Ministers about the latest state of discussions on IMF governance reforms.

The lunch took the form of a Ministerial dialogue between the Economic and Finance Ministers of the EU and the Acceding and Candidate countries.

At the ECOFIN itself, the Council reached a general approach on the revised capital requirements rules (CRD IV). The Council adopted conclusions on the 2012 Ageing Report and on Fast start climate finance.

<u>The Committee</u> discussed the outstanding issues concerning the draft Directive. Some delegations maintain a general scrutiny reservation on the text, while two delegations indicated that they are at present not in a position to accept the compromise text. The Presidency took note of these indications. <u>The Committee</u> will revert to the matter at one of its future meetings.

### 29. Follow-up of the Council meeting (Foreign Affairs/Development) on 14 May 2012

<u>The Committee</u> received a debrief on the FAC/Development meeting on Monday 14 May 2012 by the EEAS SG Pierre Vimont.

Afghanistan: the Council conclusions will be useful in view of the Chicago summit but also for the Kabul and Tokyo conferences; delegations called to improve coordination and urged the Afghan Government to fulfil its commitments, including on legal immigration (Commission is also looking at these issues closely).

MEPP: need to follow closely the evolution of the new Israeli Government; Gaza should not be forgotten, there have been recent improvements as exports from Gaza are now allowed. Syria: important to continue outreach towards Russia (and also China), also keeping in mind the 6-point plan by Kofi Annan, the EEAS will continue outreach to the different communities; several delegations called for increasing the number of observers (now 300); however the context of a very dangerous situation on the ground has to be taken into account. Libya: EEAS is working with the government on the preparation of the elections, including with a tailor-made electoral observation mission; discussions are on-going on how to work together more effectively (this will also be determined with the new government); the HR stressed the need for EU coordination.

Mexico: the summit will be important but discussions also focused on Argentina.

Discussions over lunch (report though COREU) focused on Ukraine and Russia. On Ukraine: need to follow closely the situation on the ground and the outcome of the elections; Russia will be discussed in depth at a later stage.

In relation to organization, it was noted that Council conclusions agreed by Working Groups, PSC and the Committee should not be re-opened unless this is justified by major internal events.

Two Ministers wished to report, under AOB, about their visit to Bosnia: appeal by the HR to do such debriefs at the level of CRP or alternatively to address her a note in writing. Development Minister regretted about the late hour of their meeting: the HR is ready to consider alternative solutions but it is difficult to foresee a meeting on a Tuesday (day of the GAC) or in alternative interrupt the FAC for a longer time - legally there are no obstacles to resume the FAC on Wednesday (this is however the day when the Collège meets). European Football Championship: Pierre Vimont called upon delegations to avoid declarations at this stage, the situation will be re-examined closer to the start of the event.
