#### Swedish statement

"Sweden wants to make it clear that it has voted against that an appeal should be lodged by the Council in the joined cases T-439/10 (Fulmen v. Council) and T-440/10 (Fereydoun Mahmoudian v. Council), for the following reasons:

- The principle of the right of the accused to know the reasons behind the accusation is crucial in any democratic society and a fundamental Human Right.
- Any Court taking judgment of a case of listing, such as Fulmen and Mr. Fereydoun Mahmoudian, should have the right to take part of the information being the reason for the listing in question. It is inappropriate that a listing exclusively be based on confidential information, that neither the Court, nor the listed entity/person can be informed about.
- Furthermore, it would not serve the interest of the EU as a responsible global actor and defender of the rule of law that the case, following an appeal, again be lost."

#### Finnish statement

"While recognizing the importance of using confidential information as the basis for decision to designate individuals and entities, it is our view that basing such decisions exclusively on information which cannot be shared neither with those designated nor with the courts cannot be reconciled with fundamental rights as protected by the EU legal order. In addition, it is our view that the chances of an successful appeal in this case are very limited.

For these reasons Finland will vote against an appeal by the Council in the joined cases T-439/10 (Fulmen v. Council) and T-440/10 (Fereydoun Mahmoudian v. Council)."

# "STATEMENT BY POLAND ON THE REVIEW THE DIRECTIVE OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL AMENDING DIRECTIVE 1999/32/EC AS REGARDS THE SULPHUR CONTENT OF MARINE FUELS

In principle, Poland supports the initiative to review the Directive of the European Parliament and of the Council amending Directive 1999/32/EC as regards the sulphur content of marine fuels with regard to include IMO regulations in the EU law.

However, it is being estimated that both revised MARPOL Annex VI and the revised directive will lead to significant rise in fuel price and distortions in competitiveness between SECA and non SECA regions. The issue of the competitiveness of maritime transport as an environmentally friendly alternative to the road transport and possible modal shift are of great concern to Poland.

Therefore, elaboration of the Staff Working Paper "Pollutant emission reduction from maritime transport and the sustainable waterborne transport toolbox" (*The Toolbox document* - art. 7 para.2a), financial measures as in the art. 4f, as well as future legislative proposals (as in art. 7 para. 2) in favour of operators affected by this directive are of very high importance.

Additionally, Poland is of the opinion that the word "operators" covers both ship operators and port operators as ports will be equally affected by the above mentioned distortions and therefore eligible for financial aid."

<u>The Committee</u> took note of the Commission's draft Visa Liberalisation Roadmap for Kosovo as revised during the meeting in order for the Commission to move forward with its implementation.
