#### Statement by Sweden

"Sweden strongly supports the reform of the solvency and risk management regimes of insurance companies brought about by Directive 2009/138 on the taking up and pursuit of the business of Insurance and Reinsurance (Solvency II). The Directive should be implemented and applied as soon as reasonably possible. Regrettably, the adoption of the amendments to Solvency II included in the proposed Directive amending Directives 2003/71 and 2009/138 in respect of the powers of the European Insurance and Occupational Pensions Authority and European Securities and Markets Authority (Omnibus II) has been postponed. From our perspective, it is not possible to separate the transposition of the Solvency II Directive from the transposition of the amending Directive (Omnibus II) since the latter contains extensive changes to the substance of Solvency II.

Omnibus II cannot be expected to be adopted until the autumn of 2012. At that point, the Swedish government is constitutionally required to put proposed amendments to national law, aiming to implement Omnibus II, to a public consultation. Further, the proposed legislation must be reviewed from a constitutional and legal perspective by the Council on Legislation. Naturally, the reading in parliament then follows. That reading will take 2-3 months to complete. Regrettably, Sweden will, given the aforesaid, most likely not be able to comply with article 309 (1) of Directive 2009/138, as amended by the proposal. Swedish national legislation transposing Directive 2009/138, as amended by Omnibus II, cannot be adopted until the end of 2013 at the earliest."

#### Statement by the Czech Republic

"The Czech Republic strongly supports the introduction the new risk based solvency regime pursuant to the Directive 2009/138 on the taking up and pursuit of the business of Insurance and Reinsurance (Solvency II). We believe it should be implemented and applied as soon as possible, but under circumstances that are reasonable for all respective stakeholders.

As the adoption of the proposal of the Directive amending Directives 2003/71 and 2009/138 in respect of the powers of the European Insurance and Occupational Pensions Authority and European Securities and Markets Authority (Omnibus II) has been delayed, we understand the urgent need to postpone the transposition and application of the Solvency II Directive. Only for these reasons we support the proposed Quick Fix Directive so as to avoid a state of legal vacuum after 1 November 2012.

However, in general, we have strong concerns whether the setting of the transposition and application dates is realistic. In our opinion, a period of six months, delimited by the dates 30 June 2013 and 1 January 2014, is not sufficient for preparation of all stakeholders to a new regime, especially not for approval procedures. It is far not certain whether the level 2 and level 3 measures will be adopted and published by 30 June 2013. A national legislation transposing the Solvency II Directive might not be in conformity with the level 2 and level 3 measures as their content will not be fixed in sufficient advance. Moreover, all stakeholders will have to prepare for the new regime according to legislation which will not yet be in force.

For these circumstances, which create a legal uncertainty, the Czech Republic will propose, within the Omnibus II Directive negotiations, postponement of application of the Solvency II Directive to 1 January 2015."

#### Statement by Luxembourg

"Le Luxembourg rappelle que bien que l'objectif de la réforme du schéma de préférences tarifaires généralisées soit de venir en aide aux pays qui en ont le plus besoin, le pilier principal de la proposition actuelle ne rend pas entièrement justice à ce principe. "Finland declares that its position to the proposed amendments to the Regulation of the European Parliament and of the Council applying a scheme of generalised tariff preferences, and especially Article 9.1b thereof, shall be without prejudice to Finland's position regarding the law on reservations to treaties and the legal effect of invalid reservations."

The President in its opening remarks said that items 6 and 7 will be taken together as these two proposals have about 60% in common. Both dossiers have been under examination in the Technical Harmonisation (Motor Vehicles) Working Party for two years and that now it is time to start negotiations with the European Parliament as they have voted their amendments and gave a mandate to their Rapporteur in view of a possible first-reading agreement. All delegations but one gave the Presidency a mandate to start negotiations with the European Parliament in view of a first-reading agreement which is considered desirable by all. Member States will be informed of the negotiations through the Working Party on Technical Harmonisation (Motor Vehicles) which will also continue in parallel to finalise the Council text.

The Chair first debriefed the Committee on the 5th trilogue on 5 June 2012 where a provisional understanding could be reached notably on Articles 8a, 9, 13, 13a, 14, 15, 19a and 21a and the European Parliament side was able to prioritise its requests, the most important being more ambition on Art. 6, for which the EP suggested three options, then Art. 3a, 10 and 19, in relation with the impact of the EED on the ETS. The Chair then tested the mandate for the final trilogue on 13 June 2012, as outlined in document 10725/12 and including the three options suggested by the EP. The discussion showed that there was no margin of manoeuvre left regarding Art. 6 while Art. 3a could be considered as long as deep renovation would only have to be undertaken if cost-effective: on that basis and with minor adjustments to Art. 3a, 4, 5, 7 and 8A and B the mandate was adopted, without the support of DE/ES/FI/PT.

Ministers may also discuss Egypt, following the second round of presidential elections. Libya will be discussed in July.

In view of developments on the ground, Council conclusions on Syria and possibly Egypt may be prepared.

Pakistan: Ministers will discuss relations with Pakistan following the HR's visit of the country on 5-6 June 2012 and the start of the strategic dialogue. Council conclusions may not be necessary, as the engagement plan already has been in place.

BIH: Ministers will discuss the future of BIH in the light of positive movements towards European perspective (reconfiguration of the OHR will also be tackled), with the aim to adopt short Council conclusions to welcome the positive steps and to call for necessary constitutional reform.

Human Rights package: FAC will aim at adopting the Human Rights package (EU Strategic Framework, Action Plan and mandate for the new EUSR on Human Rights).

During lunch, Ministers will have an informal exchange of views on Iran, following talks in Baghdad on 23 May 2012 and Moscow on 18-19 June 2012.

<u>The Committee</u> was also informed of the Ministerial meeting with the Gulf Cooperation Council which will take after the FAC at 17h00 and will finish with a dinner starting at 20h00. Delegations were requested to provide information on the participation of their Ministers.
