1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 10973/12 FIN 408 SOC 506, accompanied by the corresponding proposal for transfer of appropriations No DEC11/2012 within Section III - Commission - of the general budget for 2012, as recorded in document 10974/12 FIN 409.
  
2. The proposal aims at mobilising an amount of EUR 6 455 104 under the EGF to meet an application from Denmark to deploy the Fund in connection with redundancies in the shipbuilding industry, arising from the delocalisation of production to lower-cost non-EU countries as a consequence of recent global financial and economic crisis.

The purpose of the proposed transfer of appropriations is to move an amount of EUR 6 455 104 in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
4. The Budget Committee examined both proposals at its meeting on 14 June 2012.
5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
  - adopt the Decision on the mobilisation of the EGF, as set out in document 10973/12;
  - approve the proposed transfer of appropriations, as set out in document 10974/12;
  - approve the annexed draft letter to the European Parliament and to the Commission to that effect.

In accordance with Point 28 of the Interinstitutional Agreement of 17 May 2006 and with Article 12(5) of Regulation (EC) No 1927/2006 of the European Parliament and of the Council of 20 December 2006 establishing the European Globalisation Adjustment Fund<sup>1</sup>, the Council has approved the Decision on the mobilisation of the European Globalisation Adjustment Fund (application EGF/2011/008 DK/Odense Steel Shipyard from Denmark) as presented by the Commission (COM(2012) 272 final).
