## 15. Council Regulation amending Regulation (EC) N° 975/98 on denominations and technical specifications of euro coins intended for circulation

"While supporting the objectives of the proposed Regulation, the principle of retroactive application to euro coins already in circulation stemming from Article 1j is not acceptable to the Republic of Slovenia despite a relatively long transitional period.

Given that the designs of the Slovenian euro coins are not in accordance with the first paragraph of Article 1e which stipulates that the national side of circulation coins shall bear a circle of 12 stars that shall fully surround the national design, including the year mark and the indication of the issuing Member State's name, the Republic of Slovenia would be obliged to change all denominations of Slovenian euro coins. The Republic of Slovenia does not agree with the interference on the designs which will be valid at the entry into force of the Regulation and believes that the existing designs should remain in force while the new rules should only apply to the newly issued euro coins.

Therefore, Slovenia votes against the proposed Regulation and will continue to closely follow the issue."

<u>The Committee</u> had an exchange of views on the basis of documents 10861/1/12 REV 1, DS 1423/12, 1426/12, 1429/12 and 1433/12. It was concluded that following this discussion and the consequent changes to the text, the Presidency had a clear mandate for the fifth trilogue.

The Committee had an extensive exchange of views on the blocs on thematic concentration, financial instruments, net revenue generating operations and public private partnerships and the performance framework, as set out in ADD 1 to 4 to document 11027/12. It reverted with a new Presidency compromise proposal concerning the blocs on thematic concentration, net revenue generating operations and the performance framework. Taking into account delegations comments, the Presidency will submit the four thematic blocs to the Council with a view to reaching a partial general approach on them.

Declarations are made by LT, LV and PL delegations:

### "Declaration by Lithuania and Latvia

## <u>Declaration on Article 32(7) CPR (combining of financial instruments with grants within the context of double financing and cumulation)</u>

"Latvia and Lithuania understands that Article 32(7) provides for the opportunity to combine financial instruments with grants and other financial instruments considering that the combination of support may cover the same expenditure item provided that the sum of all forms of support combined does not exceed the total amount of the expenditure item concerned, the sum being calculated as state aid equivalent, and provided that support combined may cover the same eligible costs (expenditures) within the limits of applicable EU state aid rules. Grants shall not be used for re-payment of loan interests.

When support provided through financial instruments is repaid or expires, there is no double financing with grant support or other financial instruments."

#### "Declarations by Poland

#### 1. Declaration on performance reserve, framework, and review

Poland strongly supports the performance framework, review as well as the performance reserve which now - by the decision of the Presidency - is being negotiated within the Friends of Presidency for Multiannual Financial Framework 2014-2020. Poland believes that the performance reserve is an integral part of implementation of cohesion policy and is a positive incentive for Member States to effectively and efficiently implement the funds of the Common Strategic Framework and thus is in the position that all elements of the performance mechanism shall be discussed together. Therefore, Poland proposes to remain the possibility to come back to the discussion on the performance framework after the decision of the General Affairs Council on the obligatory performance reserve is taken and when discussing indicators during the Cypriot Presidency.

From the beginning of negotiations of cohesion policy legislative package, Poland has been calling for more result-oriented cohesion policy and regular open political debate on the progress on the implementation of the strategic objectives. Having that in mind, Poland with difficulty accepts the fact that proposal on the performance framework has been weakened as majority of Member States do not notice the value added of this mechanism. However, Poland is going to keep its strong favorable position on performance framework and reserve, and therefore, believes that performance reserve will remain obligatory and other Member States which support better spending would take more open approach towards this mechanism at the further steps of the negotiations.

### 2. Declaration on financial instruments

Poland remains sceptical about the financial instruments to be implemented at the EU level and thus underlines that they shall not be treated with priority and the Member States are entirely free to select at which level (EU, national, regional) they want to set up the financial instrument.

Moreover, Poland reiterates the necessity to return to the issue of financial instruments in urban and rural context when discussing territorial instruments block.

## 3. Declaration on Annex XXX to Art. 54 (definition of flat-rates for net-revenue generating projects)

Poland welcomes the initiative of real simplification of the procedures concerning revenuegenerating projects. However, Poland considers that the discussion on the Annex XXX may need to be re-opened at the later stage of negotiations taking into account the results of negotiations on the issue of VAT eligibility."

The Committee had a discussion, with a view to the forthcoming meeting of the EC on 28 and 29 June 2012 on the basis of draft guidelines provided by the PEC. The exchange focus on the main topics of the agenda, notably the promotion of growth, the Single Market Act, the European Semester, the Multiannual Financial Framework.

At the meeting of 13 June 2012 the Polish delegation lifted its reservation on the statement on the European Endowment for Democracy, and asked that this statement be included in the Council minutes. This request was accepted by all, with the exception of the French and Portuguese delegations.

<u>The Committee</u> also held an in-depth discussion on the main outstanding issues in the European Neighbourhood Instrument (ENI - Article 4(2) and Article 7(2), 7(3) and 7(6)) and the Development Cooperation Instrument (DCI - Article 5(2) and Annex II).

<u>The Committee</u> agreed to the suggested new wording of Article 3(9) of the DCI. The Presidency also tabled a compromise proposal for ENI which was further discussed at the meeting of 14 June 2012, but discussions were inconclusive.

Although the Spanish and Italian delegations maintained a reservation on Articles 3(3) and 8(3) of the Instrument for Stability, the Committee found sufficient support for the text of the instrument at its meeting of 13 June 2012.

The Committee agreed the revised draft Council Decision as set out in 11249/12.

The Commission indicated it would make declarations regarding granting voting rights to the Associated Countries and on the issue of the substantive legal basis of the recommendation.

#### 35. Preparation of the Council meeting (Foreign Affairs) on 25 June 2012

#### Other items in connection with the Council meeting

The Committee took note of information provided by SG of the EEAS, Mr Vimont, setting out the provisional timetable and agenda items for the FAC meeting on 25 June 2012. First, the Council will discuss the Southern Neighbourhood with a focus on Syria and with the aim of adopting conclusions. The Council may also discuss Egypt in light of developments on the ground and available time.

On Pakistan the High Representative will provide feedback on her recent visit and the strategic dialogue. The EEAS took note of UK/SE/DE proposal to adopt conclusions on Pakistan.

The topic of Bosnia and Herzegovina will be discussed in light of the outcome of the May PIC meeting and also of the current domestic political difficulties, with conclusions foreseen. The Council will have a comprehensive discussion on Human rights, with the objective of adopting the strategic framework document, the related action plan, and the EUSR mandate. The EEAS expects the selection process of the EUSR to come to a conclusion before the Council meeting. Iran will be discussed at a restricted (Ministers only) luncheon session, with special focus on the follow-up to the Moscow talks and on other issues related to the application of the sanctions regime. Further, the EEAS expects the Council to adopt conclusions on the European Neighbourhood Policy, on Central Asia, and possibly on the Arms Trade Treaty.

The Council meeting will be followed by the EU - Gulf Cooperation Council meeting and dinner.

The EU - Moldova Cooperation Council meeting will take place on 26 June 2012.

<u>The Committee</u> took note of the Commission intention to raise the Belarus visa facilitation regime as an 'AOB'. It also took note that the issue of attacks against Christians in Nigeria, raised by IT, could be addressed under the human rights topic.

The EEAS took note of FR proposals to adopt conclusions on Yemen and to address the situation in Mali.

## **36.** Preparation for the EU-Mexico Summit (Los Cabos, Mexico, 17 June 2012) 9237/12 AMLAT 19 PESC 512 RELEX 482

<u>The Committee</u> was informed, on the basis of document 9237/12, of the state of play of preparations for this Summit.

The <u>EEAS</u> indicated the objectives pursued by the EU:

- 1) prepare the G20 discussions on the financial crisis with a view to avoiding misperceptions of the European stance;
- 2) consolidate the dialogue EU-Mexico on Bilateral issues and on Global Challenges (trade, environment, climate change) with a view to reaching common positions; and
- 3) improve bilateral relations through better implementation of the existing instruments (Global agreement: to be completed?-open question, Joint Executive Plan: to be further implemented).

It was furthermore sought to enhance the cooperation with Mexico, a Strategic Partner, in the field of foreign affairs.

The Commission focussed on three areas:

- 1) trade, where the existing FTA should be developed further and protectionism in Latin America should be rebutted;
- 2) environment, where Mexico was a close ally, promoting the concept of Green Growth; and
- 3) climate change, where Mexico was a very close ally with whom progress should be aimed at

No delegation intervened.
