Subject: Proposal for transfer of appropriations No DEC21/2012 within Section III -

Commission - of the general budget for 2012

1. The Commission submitted to the Council a proposal for a transfer of appropriations
No DEC21/2012 within Section III - Commission - of the general budget for 2012.

The purpose of this proposal is to reinforce Article 23 02 01 (*Humanitarian aid*) with EUR 70 million and Article 23 02 02 (*Food aid*) with EUR 10 million in commitment appropriations through a transfer from Article 01 03 02 (*Macroeconomic assistance*) an amount of EUR 57 million, from Article 15 02 03 (*Cooperation with Third countries on education and vocational training*) an amount of EUR 3 976 000 and from Article 40 02 42 (*Emergency aid reserve*) an amount of EUR 19 024 000.

Moreover, it is proposed to transfer the necessary amounts in payment appropriations from Article 01 03 02 (*Macroeconomic assistance*) by an amount of EUR 29.7 million and from Article 40 02 42 (*Emergency aid reserve*) by an amount of EUR 10.3 million to Article 23 02 01 (*Humanitarian aid*) with EUR 35 million and Article 23 02 02 (*Food aid*) with EUR 5 million, as recorded in document 11873/12 FIN 475.

- 2. The transfer is being proposed in order to provide humanitarian assistance for the following crises: Sudan and South Sudan with an amount of EUR 40 million, Yemen with an amount of EUR 20 million and Syria with an amount of EUR 20 million.
- 3. The Budget Committee examined the proposal for a transfer at its meeting on 2 July 2012.
- 4. In accordance with the provisions of Point 25 of the Interinstitutional Agreement of 17 May 2006, a simplified trilogue was held on the Commission proposal.
- 5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in ANNEX to that effect.
