- Proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund in accordance with point 28 of the Interinstitutional Agreement of 17 May 2006 between the European Parliament, the Council and the Commission on budgetary discipline and sound financial management (application EGF/2011/017 ES/Aragón Construction from Spain)
 Proposal for transfer of appropriations No DEC14/2012 within Section III -
- 1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 11555/12 FIN 452 SOC 591, accompanied by the corresponding proposal for transfer of appropriations No DEC14/2012 within Section III Commission of the general budget for 2012, as recorded in document 11556/12 FIN 453.

Commission - of the general budget for 2012

2. The proposal aims at mobilising an amount of EUR 1 300 000 under the EGF to meet an application from Spain to deploy the Fund in connection with redundancies in the construction sector, where demand for new houses has decreased significantly, due to a reduction of loans to the sector and to individuals, as a consequence of the global financial and economic crisis.

The purpose of the proposed transfer of appropriations is to move an amount of EUR 1 300 000 in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

- 3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
- 4. The <u>Budget Committee</u> examined both proposals at its meeting on 25 June and 5 July 2012.
- 5. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the Decision on the mobilisation of the EGF, as set out in document 11555/12;
 - approve the proposed transfer of appropriations, as set out in document 11556/12;
 - approve the annexed draft letter to the European Parliament and to the Commission to that effect.
